# **BUSINESS LICENSE INFORMATION**

Welcome to the City of Perris! We appreciate your choice in selecting the City of Perris to conduct your business. In an effort to keep new and potential enterprises informed, we encourage you to come into the Finance Department and ask questions... we are here to help you!

The following information has been compiled and provided to all new Business License Applicants, any errors or omissions in this list will not excuse business owners of their responsibility or liability in establishing a business license in the City of Perris.

You can use the City's website to download the Business License Application form. The website offers information on how to obtain a business license and includes a helpful section for frequently asked questions and answers.

A City Planner (951) 943-5003 or Building Official (951) 443-1029 from the City of Perris will be glad to answer questions you may have relating to the following:

**ZONING:** Is the prospective location or building you are looking at zoned for the type of business you plan to engage in?

**BUILDING:** Is the building up to present City codes (structural, electrical, etc)?

**SIGNS:** If you plan to erect advertising structures, you must apply for sign permits.

**MISCELLANEOUS:** Commercial hoods, grease and/or sand traps, building permits, etc, may be required before your business can be opened.

Special permits are required for solicitors or peddlers, secondhand dealers, swap meets, amusement centers, tow trucks, taxis, bingo games, yard sales, dog kennels, ambulances, large family daycare centers, alarms, filming, and painting numbers on curbs.

The payment of a business license fee for transacting and carrying on business under Title V will not relieve you from the payment of any fee for the privilege of doing such business required under any other ordinance of the city or the regulatory provision of other ordinances.

Upon receipt of a business license a change of your locations or ownership of the business should be filed with this office. A new application is required for both instances. A change of location will not incur an additional license fee, but there is a nominal fee for a replacement license. A change of ownership is treated as a new business.

Please complete and return a Business Contact Card with the Sheriff's Department. This is for your benefit in the event of an emergency.

Businesses are expected to and are responsible for meeting any City, County, State, and Federal licensing requirements. The following is a list of websites where additional information can be found:
