APPLICATION REQUIREMENTS

The following requirements must be submitted with the application in order to commence the Landscape Plan Checking Process:

- Fee of \$200.00 per page plus \$8.45 for data process fee made payable to: **The City of Perris.**
 - Three (3) complete sets of the planting plans, irrigation plans, and associated details. These plans must be no larger than 24 x 36 and folded to 8 ½ x 11. *Resubmittals also require (3) complete sets.*
 - A digital copy of the plans are also required via USB or CD.
- A. Landscape design plan.
 - B. Irrigation design plan.
 - C. Water Quality Management Plan (WQMP) site design BMP's
 - D. Planting details (per the City's Technical Manual for Landscape Design), including but not limited to:
 - a. Tree staking (double-staked)
 - b. Groundcover spacing
 - c. Planting specifications (trees and shrubs)
 - d. Root barriers as necessary
 - E. Maintenance schedule.
 - F. Water usage calculations as stipulated in Section 19.70.030 of the Perris Municipal Code.
 - G. All irrigation equipment to be installed in the public right-of-way, which will be maintained by the City through the Landscape Maintenance District shall conform to the attached equipment list.
 - H. Two (2) sets of construction grading plans. Grading plans are critical to identify slopes, walls, detention basins, swales, location of utilities and paved surfaces.
 - I. One (1) copy of the soils sampling analysis.
 - J. The drawing must be prepared by California Licensed Landscape Architect.
 - K. Approval block for City signatures located on the bottom right corner of the title page.
