8. PUBLIC HEARINGS:

A. Consideration and discussion to approve proposed Development Agreement No. 03-0003 to implement the development of a Master Plan Community known as Villages of Avalon. Applicant: Barratt American.

Community Development Director Gutierrez gave an overview of Development Agreement No. 03-0003. She stated the Villages of Avalon is a Master Planned Community that is currently under development, consisting of residential land use mix and recreational open spaces and doing very well in the The developer had requested a development agreement in which the City would receive certain benefits as would the developer. The developer offered a one time \$1 million dollar to the City of Perris for the construction of Rider. Rider Street had been a problem street in terms of impacts from development as well as the school. The developer is willing to assist the City in addressing the circulation, traffic and safety issues, with their contribution towards the construction of Rider Street. There are other contributions proposed by the developer to address further circulation issues within their master planned community as well as to assist the adjacent community which is the May Ranch. This would be for improvements to internal streets they are not conditioned for at this time. improvements include Avalon Parkway, to Bradley road, between Evans road, totaling around \$600,000 that the developer brings to the table for the internal improvements. They are doing improvements to the Ramona Expressway which consists of a bike/pedestrian trail and contributing to the master drainage study for the area. She further added that it would include the Rider program. The Rider program included a contribution the developer will be advancing to the school district. This contribution would be put towards complete improvements to Rider Street.

Mayor Busch clarified that a meeting did not take place on Saturday to discuss development agreements. He also clarified that no plans had been changed and negotiation of terms on the agreements were taking place. Mayor Busch asked Community Development Director Gutierrez to explain on a visual what would be taking place in the public's interest area.

Community Development Director Gutierrez explained that the development agreement did not change the land use plan that the project was approved under. It does not change the type of improvements that they are required to do previously. They are accelerating the improvement schedule. They are actually bringing the improvements forward so they can construct Rider Street. This is not a cost to any citizens. The money will come from two developers coming together. Another thing that will affect Rider Street is they are also accelerating the rate at which the storm drain will be addressed. Some of the flooding issues will be alleviated. Most of the improvements making are internal streets.

Community Development Director Gutierrez reviews agreement

City Engineer, Motlagh explained to the public that part of the agreement with Barratt would bring about contribution of \$1 million dollars. This would be used to supplement the \$800,000 that had the City had previously worked with KB homes under a separate development agreement. The \$200,000 that the City was hoping to get from the school district would be included to make a \$2 million

City Engineer, Motlagh explains agreement with Barratt American could bring a contribution of \$1 million dollars to City of Perris dollar project to widen and improve Rider Street to a minimum of four lanes. Perris Valley Channel project would be forthcoming in the future.

Engineer Motlagh expressed his view that within the next two years there would be improvements at Rider St. with a traffic signal installation, and 3 other traffic signals installed on Evans Road/Rider, Bradley/Rider and Ramona Expressway/Rider. Engineer Motlagh apologized for the inconvenience to the public, but installation of utilities must take place before pavement laid down.

Councilmember Landers suggested that Barratt American get together with homeowners to answer questions. He was in favor of the public keeping their horses.

Community Development Director Gutierrez announced that the developers was currently building in the City along Goetz Road and would like to continue to do so. The developer had come forth in an effort to work with the City to also be exempt from the TUMF fees. The development had 451 units and a very large piece of property of approximately 150 acres. The developer had discussed with staff and submitted a conditional use permit that is on hold for the development of a golf course. Community Development Director Gutierrez added that developer would like to work for the City to establish a finance mechanism. The developer proposes to pay \$3,000 per unit that would be placed in an account for a short period of time while the feasibility of the course is arrived at. Should the golf course proposal never materialize the money would go to the City of Perris towards parks. That amount is about \$1.3 million, which would be a benefit to the City. In addition there is a \$500.00/unit that would be placed in a park fund towards development of a park in the downtown area. Language has been modified relating to CFD finance language.

City Attorney, Eric Dunn announced that the economic terms spelled out by Community Development Director Gutierrez are in place a few issues that needed to be incorporated to the agreement.

Community Development Director Gutierrez announced negotiation had been taking place with John Reichl. The first tract map consisted of approximately 103 units, located on the northwest corner of Jarvis and Redlands. The second tract is a proposed tract is located in the Downtown Specific Plan, east of the Sante Fe Railroad between Midway and Ellis St. in the downtown area. Director Gutierrez added that both sites being proposed to develop and are currently zoned R14 and allow apartments 14 units/acre. The developer is proposing single family detached at both locations. The developer is proposing to contribute \$3,000 a unit for a park fund. The City would propose to use that towards the downtown.

items. The reason for that is to protect the person who is the subject of the Closed Session. If you are going to make specific complaints and charges against a person, then a person is entitled notice of that and to have actual name clearing hearing. In this particular case it was a personnel item evaluating the City Manager, no action was taken on the Thursday meeting. There was a resignation offer placed on the table, that was discussed but not accepted Thursday night. Events in the ensuing time just led the Council to want to agendize the item again. In that discussion they took some action. At this point, from a legal perspective it is not appropriate or wise to go into great detail why they made the decision. Frankly there could be a lawsuit about it. I would say that in this business, you work on a At-Will basis on a contract, you have five bosses and if three of them don't like the color of your hair or your suit, that's all they need. The contracts are written and a person in our position can be terminated without cause. That was the action taken by the City Council on the Saturday meeting. I hope that answers questions, I really appreciate the public's position on this. There are very legitimate reasons for not going into great detail about what was discussed. It's unfortunate and that's just the way it needs to be."

Councilmember Yarbrough stated, "In the past there were City Managers that could not last a year because of the politics. Mr. Vasquez was here over 26 months which is a normal course you will see, two, three, four years for a City Manager, former City Manager Molendyk was here 30 months. We are going through a natural evolution and these changes are difficult sometimes. You see them in your jobs and your families. We have a decision as the attorney stated, his public contract that is on file states that we can let him go for any reason or no reason. I think the fact that the City continues to run and operate says a lot about the organization."

13. CITY MANAGER'S/EXECUTIVE DIRECTOR'S REPORT:

Acting City Manager Apodaca announced the City would be hosting a Wake Up Perris, on Tuesday 7:30 a.m. in the Library Community Room. On March 11th staff would be bring forth a design concept for the CalTrans Roundabout proposed for Redlands and 4th. He also received word from the County of Riverside that the City's contract to purchase three parcels on Redlands and Dale for future park sites is on a fast track process. The City should get an executive order to issue a check in three months. That will give the City about ten acres. Mr. Apodaca also added that the City had met with representatives of a proposed \$200,000 retail project. He hoped that they would be pulling permits soon. We hope that this project will trigger other retail development in the surrounding City.
