Marion Ashley, Riverside County Supervisor for the Fifth District, urged Council to consider carefully the Transportation Uniform Mitigation Fee (TUMF) Ordinance and to participate. In participation, more roads would be completed. There were flaws within the plan and one of those were the job Riverside County Transportation area of the commercial/industrial. Councilmember Yarbrough commented that this was a second reading of an ordinance for the City to participate in the Western Riverside Transportation Uniform Mitigation Fee Program (TUMF). The project was to impose fees on development for infrastructure monies. The program entailed the region as well as the City of Perris. The City had, conceptually, presented resolutions supporting the program; Council thought that it was necessary and the developers were receptive to the program. The fee was imposed at \$6,600 per unit for residential instead of a \$1,000 or a \$2,000 fee. Councilmember Yarbrough previously expressed issues and was disappointed that there was no option but to participate. Councilmember Yarbrough encouraged Council to support the ordinance, but he did not support the program.

Councilmember Yarbrough's Comments Re: TUMF Participation; **Conceptual Resolutions** Supporting the Program; Voiced Concerns The County would give to the Needs of Perris

Councilmember Rogers commented that Council had studied the TUMF through workshops and meetings. The measure would affect the City of Perris with industrial/commercial growth. jurisdiction had to participate for the program to work. There was a negative impact to the City, but look at the broader aspects for all of the residents that were commuters and the Inland Empire. The quality of life was vital to have adequate transportation corridors that did not stifle one everyday, but continued to move and progress. The Council was obligated to look at the broader measurement; neighboring communities and to support this measure.

Councilmember Landers commented that there was no choice and there had to be a mechanism to repair roads and streets. The City had to be in partnership with other cities. Therefore, Councilmember Landers would vote for approval under duress.

There was language inserted within the General Plan, which stated that this highway had to be done in conjunction with the building of the 215, 60 and 91

Interim City Manager Apodaca commented that this authorization was for the completion of Phase I City Hall Campus Expansion and Renovation. The first component, request for funding authorization. covered the finalization of office space so that Community Development could start operation in the new County building adjacent to City Hall, 135 N. 'D' Street. It also covered the extension of computer cabling and drops; telephone cabling; modular furniture; switching of offices (Administration and Finance); creation of a payment lobby; and all the movement created the touch up of doorways; partitions; and walls. The City Clerk's office would be relocated in the old Finance Department. This phase was to create more office space. It also included finalizing conceptual plans for restoration of the old police building for conversion into City Hall Council Chambers. The restoration plans included an audiovisual room, closed session room with kitchenette, five offices for Council and seating for 125 people. The overall Campus Plan developed an historical mission modernistic look. The tennis courts would remain, but the model auto-racing rink would be removed and that would be the beginning of campus parking. The idea was to integrate

Community Development Director Gutierrez commented that the proposal was a conditional use permit to construct a wind tunnel. The airport was one of three top facilities that had worldwide fame.

The wind tunnel was approximately ninety-six feet in height and simulated flight training for skydivers. The ordinance amendment allowed deviation of height within the zone. Phase I of the proposal consisted of a parking lot, wind tunnel and a modular office unit. The Planning Commission had reviewed the proposed application and gone through a number of issues, which included the height limitation. The height limitation was addressed by the ordinance amendment, which actually required/allowed for deviation of height to increase the setback for the structure for every foot of additional height. Other items considered were noise and the structure fell within the allowed decibels of the General Plan Noise Element. As proposed the project was consistent with the General Plan, the zoning ordinance, and had a full detail review. Therefore, the Planning Commission recommended adoption of Negative Declaration 2121 based on the findings that the proposed project had no significant adverse affect on the environment, to approve Ordinance Amendment 02-0255 and approve Conditional Use Permit 02-0261. Language in Condition No. 20 was revised to reflect that they had an annual review as opposed to an extension of the conditional use permit. The applicant was in concurrence with the conditions.

Ms. Melanie Conatser, Perris Airport Proprietor, commented the investments made were for the airport as well as an asset to the City. It had been a pleasure to work with staff and was honored to be a part of the City. The airport had a good working relationship with the City. The City allowed the airport to be placed on the map and it would be the biggest and best drop zone in the world.

City Attorney Dunn commented the resolution set the date for public hearing in May and there was no obligation at this time. The public hearing was to consider formation of the new Community Facilities District (CFD). This project had final maps approved for the Chaparral Ridge project. The developer went through the Romoland School District to create a CFD and it was discovered that some of the units were not located within that district. Therefore, the developer came and asked the City to create a CFD for those units that were outside of the Romoland School District. They worked with the district to adjust the boundaries. The CFD was a very small Counsel for the developer asked that the bonded indebtedness be increased to \$4 million from \$3 million. This was to provide a safety factor.
