The MSHCP was designed to give agriculture the maximum level of protection that can be accomplished under the Federal and State Endangered Species Acts.

County and Cities will all become permittees under incidental take permits issued U.S. Fish and Wildlife and California Department of Fish and Game.

Overall, the MSHCP calls for local mitigation of 97,000 acres to develop 400,000 to 500,000 acres.
