9.2 **CONTINUED PUBLIC HEARINGS:**

A. Community Director Gutierrez indicated the request was to approve a conditional use permit to allow a cellular telecommunication monopole. The monopole was reduced from 65 feet to 55 feet due the concerns expressed by March JPA. There were conditions required for landscaping along Perris Boulevard and property lines; and fencing would be wrought iron. Subject to the conditions contained in the staff report, staff recommended Council to approve the conditional use permit.

10. NON-HEARING ITEMS:

10.1 NEW BUSINESS:

Mayor Busch indicated Items A, B and C would be heard jointly and motioned separately.

Mayor Busch's Comment

Ms. Shepherd, Assessment Maintenance District Engineer, introduced Flood Control Maintenance District 1; Landscape Maintenance District 1 and Maintenance District 84-1 and defined the process of annexation. The property within the districts were owned by KB Homes, Inc.

Shepherd & States Ms. Shepherd's Presentation

Maintenance District 84-1:

- Funding for maintenance of street lights and traffic signals;
- One Tract had a total of 167 residential units;
- Annual maintenance of improvements totaled \$10,500;
- Cost would be \$62.78 per single family unit; plus three inflation factors: common labor; energy for traffic signals and street lights; six month tax roll reserve; and would be considered the maximum assessment;
- All cost were divided by the assessment units in the district;
- Other areas developed would share in the cost of street lights; traffic signals along Evans and Bradley Roads;
- Assessments would be based on actual costs; and no assessment would be levied until eighteen months after the lights had been energized;
- In October, 2001 KB Homes paid a deposit to the City to pay for the eighteen month maintenance for the first phase (Tract 29993); and a similar deposit would be deposited as soon as the remaining tracts were installed.

Landscaping Maintenance District 1:

- Funding for maintenance of parks and street landscaping;
- Improvement constructed by annexation of the area included irrigation system; landscaping, sidewalks; medians; landscaping totaled 78,430 square feet;
- Replacement Funds would be established for sole use of capital improvement; and a fund would be established for use of Graffiti Removal;
- Estimated annual maintenance cost totaled \$46,014; for an annual assessment of \$275.53 per single family unit plus four inflation factors: common labor; energy for lighting; EMWD water rate; six month tax roll reserve;
- No assessments levied until improvements had been constructed and accepted by the City; and at that time, the assessments would be based on actual costs that were presented in an annual report;
- Parks: proposed annual assessment of \$66.89 per home;
- Park improvements, as required by May Ranch Specific Plan Area, may include a fifteen acre addition to the existing park; a linear park within Metropolitan Water District easement;
- Recommended assessment of \$342.54 plus inflation factors be considered as the maximum assessment; \$275.53 for street landscaping and \$66.98 for future parks was included.

Flood Control Maintenance District 1:

- Funding for maintenance of storm drain facilities;
- Annual cost for maintenance of the storm drain was review/researched by Public

Works Department; estimated costs provided by contractors that currently work for the City; owners received bids that confirmed City's estimates; Riverside County Flood Control District did the final review;

- Maintenance cost would provide for detailed upkeep required for this type of facility which included: spraying; mowing; vandalism; dumping; rodent and snake control:
- Total estimated annual maintenance cost would be \$33,530;
- If cost was divided by the units the annual assessment would be \$200.78 per single family home, plus two inflation factors: common labor and a six month tax roll reserve; and was considered as the maximum assessment;
- Other areas to benefit from the channel were in the process of development; Barratt American; Tract 30380 would be conditioned to annex to the Benefit zone 14 and assessed maintenance costs for the channel/storm drains; Villages of Avalon revenue for the maintenance of the channel would be provided by a Home Owners Association;
- Upon development of other areas and establishment of other revenue it was anticipated that the annual assessment would be equal to \$23.90 per single family home, plus inflation factors.

In summary, Ms. Shepherd said all of the districts' assessments would total \$606.07, if development ceased in all the other areas, the channel was built and the 167 units remained. What may happen would be the assessment for Maintenance District 84-1 would be in the area of \$40.00. For parks constructed, in the future, the immediate assessment would be computed in the area of \$339.43. If all the areas developed, the benefit from the flood control channel, then it would compute \$23.90 which would be a total assessment of \$403.33 for all districts.

PUBLIC COMMENT:

Mr. Shepherd, KB Home, Inc., commented on concerns of their development agreement language and responsibility for the flood control channel. He suggested to set up the assessment to include all the potential beneficiaries; condition to cite the lower number for the assessment; and obligate the builder to incur any deficient that may exist when the City accepted the channel. He recommended revisions to the Flood Control Maintenance District 1 report.

CITY COUNCIL COMMENTS AND DISCUSSION:

Mayor Pro Tem Rogers asked Mr. Shepherd if he was in agreement with Landscape Maintenance District 1 and Maintenance District 84-1 as presented. She posed a question to City Manager Vasquez regarding the current development agreement and language in regards to the assessment.

In reply, Mr. Shepherd indicated they requested a revision to the Flood Control Maintenance District 1 report.

In answer, City Manager Vasquez commented the development agreement language did not accommodate KB Home.

Mayor Pro Tem Rogers' Queries

KB Home, Inc. Mr. Shepherd's Reply

City Manager Vasquez's Reply Ms. Shepherd, Shepherd & Staats, said there was never a question that KB Home would be responsible for the maintenance of the flood control channel and provide for that until all homes were sold. If there was no development who would pay for the channel.

Shepherd & Staats, Ms. Shepherd's Comments

City Manager Vasquez said the City would like to continue discussion with KB Home to resolve the issues and recommended Council to continue and approve the proposals. There was thirty days to present specific language and addendum that would clearly delineate what the arrangement would be and presented to Council.

City Manager Vasquez's Comments

Mayor Pro Tem Rogers said she had questions on Item A, Flood Control Maintenance District 1 and asked if the Villages of Avalon and Citation Homes had been annexed to the district and assessments placed.

Mayor Pro Tem Rogers' Queries

In response, Ms. Shepherd said Citation Homes and Barratt American had not been annexed into the Flood Control Maintenance District 1.

Shepherd & Staats Ms. Shepherd's Response

City Attorney Dunn said it was a matter of timing and KB Home was the first builders. There was one tract with 167 units and the cost of \$33,000 to maintain annually and if no other units were built it would still cost to maintain. Assessments were usually imposed on developed property. Mr. Shepherd suggested to spread the assessment; and had the Barratt and Citation Projects developed the cost would be divided equally creating a lower assessment rate.

City Attorney Dunn's Comments

City Manager Vasquez intervened and indicated as development occurred the cost would be equally distributed and KB Home's reduced.

City Manager Vasquez's Comment

City Attorney Dunn said staff recommended to adopt the resolutions; set the May 14th public hearing; present a supplemental report to Council for actual approval on May 14th.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF PERRIS, CALIFORNIA, PROVIDING FOR THE PASS THROUGH OF SEWER RATES ADOPTED BY EASTERN MUNICIPAL WATER DISTRICT.

City Attorney Dunn commented there was an urgency ordinance presented to Council to increase sewer rates which was previously adopted by Eastern Municipal Water District (EMWD). There was discussion on urgency or if the rate was required. Subsequently, it was found there was a forty year Interagency Agreement, from 1980, where both parties agreed to act as the others agent for specific billing services. The City would not gain any revenue, but EMWD would follow through with a hearing. In the past twenty years there were some years where an increase was adopted by an ordinance, urgency ordinance or no ordinance, but it was passed through. City Attorney Dunn's recommendation was to adopt an ordinance to clean up prior ordinances and allow the pass through to be automatic pursuant to the Interagency Agreement and subject to EMWD adoption of a resolution in accordance with all required procedures and hearings for protest.

City Attorney Dunn's Presentation: 40 Year Interagency Agreement; Both Parties Act as others **Billing Service** Agent; Adopt Resolution to Clear up Prior Ordinances: Allow Pass Through Automatically Pursuant to the Agreement & Subject to EMWD's Adoption of Resolution in Accordance with all **Required Procedures** & Hearings

Councilmember Yarbrough commented the information should had been presented at the last meeting and informed the Council that he spoke with Betty Gibbel/EMWD to schedule a workshop. All Interagency Agreement should be reviewed annually. The City was not in a position to deny the increase.

Councilmember Yarbrough's Comments

Mayor Pro Tem Rogers voiced concern of compensation in man hours for billing services.

Mayor Pro Tem Rogers' Comment

In response, City Attorney Dunn indicated that pursuant to the agreement there was no compensation. The compensation was that EMWD did other billing for the City. By approving the ordinance the billing practice would continue and pass through of increase would be adjusted.

City Manger Vasquez commented, in 1953 the City granted a franchise to Southern California Gas Company; it expired in 1953; and had not been renegotiated. A proposed agreement was presented to the City last year, but there was no agreement in regards to terms and conditions of the lease agreement. Negotiations had occurred and two outstanding issues were the term of the Lease Agreement and the repair of street cuts. The City requested reduction of the term and negotiated for an opener every ten years. The issue of street cuts was based on the specifications presented by the City Engineer and would be adhered to by the Gas Company. The proposed resolution was to set a public hearing; was not an approval of the franchise agreement; and recommendation was to adopt the resolution as presented by staff.

City Manager Vasquez's Presentation: Franchise Expired in 1953 & not Renegotiated; Lease Agreement & Repair of Street Cuts Outstanding Issues; Reduction of Term & Negotiate Reopener every Ten Years; Gas Company to Adhere to City Engineer's Specifications; Set a Public Hearing

Mr. Albaugh, Public Affairs Manager Southern CA. Gas Company, commented the company agreed with the negotiated agreement and requested Council to move forward with the franchise procedures.

In response, Mr. Albaugh indicated the company had their own crews to perform the work with exception of major construction projects where work under direct supervision. The goal was to repair in a better condition as found and all the work performed was guaranteed.

Public Affairs Manager Southern CA. Gas Company Mr. Albaugh's Response

Councilmember Yarbrough voiced his appreciation of the Gas Company working with staff and arriving at a solution.

Councilmember Yarbrough's Comment City Attorney Dunn indicated the hearing was to be scheduled within a twenty to sixty day window and to designate the date for the hearing. City Attorney

11. PUBLIC COMMENT:

Ms. Vargas, commented on a safety issue for the Val Verde School children, which was the lack of sidewalks in the direction of Val Verde School (Orange Avenue and Indian Avenue). One year ago the City Engineer informed her that the improvements would be completed in one year; there was still the concern of safety; and requested Council to address the safety issue.

Ms. Vargas' Comments

Ms. Gibble, Eastern Municipal Water District, related that EMWD processed 6500 billing accounts for the City's trash charges; 500 of the billings included City's sewage charges; and there was a Source Reduction Recycling Element (SRRE) Fee also billed. The City billed 2,000 accounts for EMWD. There was no charge to the City for the billings as it was a reciprocal agreement.

Eastern Municipal Water District, Ms. Gibbel's Comments

Mr. McAleavey invited Council to a Volunteer Appreciation Dinner on April 11th at the Senior Center at 6:30 p.m. The dinner was to recognize the Perris Citizens Patrol, Police Explorers, and Perris Volunteer Fire Company. Mr. McAleavey gave the volunteer hours for each group and compared the hours in wages/benefits at an average of \$21.28 per hour.

Mr. Vidal commented on Council's past discussion of the northern Community Facilities District (CFD); parcel assessment; approval of CFDs; CFDs would not work alone; urgent need of a Fire Station; and implementation of a parcel assessment.

12. CITY COUNCIL COMMENTS:

Mayor Pro Tem Rogers commented on the first Town Hall Meeting held in Enchanted Heights; issues remain the same (safety, sewer, street repairs); meeting was successful and would be held again in ninety days. She commended Councilmember Yarbrough for the community meeting concept. The League of California Cities Conference was held in Banning and was attended by Mayor Busch, City Manager Vasquez and herself. Representatives from Riverside County presented an update on the Riverside County Integrated Plan. On Tuesday, March 19th, she would be serving as Val Verde Principal for the day.

Mayor Pro Tem Rogers' Comments Councilmember Yarbrough commented on launching the Community Outreach Program by the end of this month or the first week of April where the volunteer groups would be introduced to the community. The safety issue of Val Verde School was identified a year an a half ago and the City Engineer secured funding for the project; other engineering issues occurred, but the City was very close to begin the sidewalk project.
