BACKGROUND/DISCUSSION:

The purpose of this item is to appoint five candidates to the Planning Commission, as on February 12, 2019, the City Council voted 3-2 to introduce the first reading Ordinance No. 1379 to reduce the number of Planning Commissioners from seven to five, with the following notable changes:

- The current seats will now expire on June 30, 2019 instead of December 31, 2019
- > Seats one through three will expire on June 30, 2021 and every four years thereafter, and
- > Seats four and five will expire on June 30, 2023 and every four years thereafter.

The aforementioned Council action was followed by approval of the second reading of the Ordinance on February 26, 2019. The Ordinance Amendment did not become effective until June 30, 2019 instead of the normal thirty days following adoption, in order to allow the existing Commissioners to serve until June 30, 2019 while the City conducted the recruitment process for candidates that would fill the five available seats under the new Planning Commission structure.

The recruitment process began on April 10, 2019 and closed on May 10, 2019. Vacancy recruitment notices were published in the Perris City News and posted on bulletin boards in City Hall. Ads were run on the cable access channel and on the City's website which included an on-line application form. A total of sixteen (16) applications were received for the five open seats. One of the applicants was deemed ineligible as the applicant did not live in the City while another applicant, Alex Marin, is a resident but according to the County of Riverside Registrar of Voters he is not a registered voter as the writing of this report. Mr. Marin is required to be registered voter prior to the appointment hearing to be considered for nomination, and has been informed of his non-voter registration status.

NOMINATION PROCESS:

As directed by the City Council, the process for appointing the five members will be by ballots following the comments of the candidates and questions from the Council. The Mayor and each Council member will have a ballot with all 15 candidates with a blank next to each name.

Step 1: Since the Planning Commissioner terms need to be staggered, the four two-year terms will be selected first. The Mayor and Council will each mark two (and only two) candidates on their ballot. The votes will be read aloud and tallied by the City Attorney (private votes are not permitted under the Brown Act). Candidates receiving three votes will be appointed to one of the four-year terms. This process will repeat as necessary until two candidates have been selected for the four-year terms.

Step 2: The Mayor and Council will each mark three (and only three) candidates on their ballot. The votes will be read aloud and tallied by the City Attorney. Candidates receiving three votes will be appointed to one of the two-year terms. This process will repeat as necessary until three candidates have been selected for the two-year terms. At this point, a motion is in order to make the appointments selected by the process.



I have and will always keep an open mind to learning and want to see and help shape quality development in the City of Perris under the direction of the Perris City Council. I would like to continue the progress we (Planning Commission) have made, with the support of the City Council, I both shaping and in some cases reshaping land use and economic development opportunities over the years. Working with my fellow Commissioners has been, and continues to be one the most rewarding experiences I have had over the last 17 years. I will, and have always, managed to keep an open mind to learning new ideas, updated planning trends, and development concepts as the City continues to grow and develop in the 21st century.

- A understanding of site plans, Conditional Use Permits, Conditions of Approval, zoning, retail development, elements of specific plans and understanding the elements of the General Plan and
- Continue to develop an understanding of the importance of compatible land uses to ensure that new developments do not conflict with existing or future development

Work Experience:

I have worked for the City of Los Angeles for the last thirty-five (35) years. I began in the City of Los Angeles Personnel Department for one year and transferred to the Department of Transportation for five (5) years where I became a Management Analyst. In 1990, I transferred to the Community Development Department as a Program Analyst working title or civil service title Management Analyst. This was a valuable experience as I worked with poverty, very low income and low income Los Angeles residents throughout the various communities of Los Angeles. As a contact administrator or Program Analyst, I worked with non-profit 501(c) 3 agencies that provided services to residents such as information and referral services, child care, after school services, recreation service, job skills, tutoring, temporary housing assistance, domestic violence programs, gang prevention programs, funded through the Housing and Urban Developments' Community Development Block Grant (CDBG) and the Community Services Block Grant (CSBG). This was and continues to be a valuable experience as you must work with the City Council, Community Action Board, and the general public. I have also been trained in the elements of the Americans With Disabilities Act to ensure reasonable accommodation in the workplace and to ensure the facilities meet Federal and State of California requirements.

Since 2013, the Community Development Department merged with the City of Los Angeles Housing Department and is now called the Housing + Community Investment Department. The HCIDLA employees over 700 employees and in responsible in all aspects of housing from

HUD financing of loans, housing and rental apartment inspections, homeless housing services, domestic violence funding, family source social service centers, and financing the construction of HUD housing facilities to name a few. In addition, my work unit, the Operations Division also oversees the Los Angeles Homeless Services Administration (LAHSA) to find solutions to the pervasive problem of lack of affordable housing and increasing homeless populations in the City of Los Angeles.

3. In your opinion, what are the most important planning and development issues in the City of Perris?

I would categorize the following areas as the most important planning and development issues:

- 1. Maintaining a balance between continued growth and development in the context "smart growth" and "walkable communities". That is to say, ensuring there is a concentrated effort to maintain quality of life issues, such as aesthetics, and development that is committed to meeting the needs of a growing population by providing not only entry level housing (especially for millennials) but "move up" housing as families or individuals increase their economic worth;
- 2. Maintaining and implementing plans to ensure a jobs/housing balance to reduce overwhelming, but necessary, commutes to counties such as Los Angeles, Orange County and San Bernardino;
- 3. Enticing higher end "white collar" businesses and industries to ensure opportunities beyond the industrial or "blue collar" service sector. A good mix of employment opportunities makes for a healthier community.
- 4. Last but no least, there is a tremendous need for the City of Perris to actively pursue housing.density.particularly.multi-family.dwelling.units to ensure our population has sufficient opportunities for affordable housing at all economic levels. Housing density should be available for all economic levels from newly graduating youth entering the employment market, to middle to upper income residents, and seniors no longer desiring large properties that must be maintained.

4. What vision do you have for future development in the City of Perris?

I envision the following:

A. The City progressively pursue mixed use development specifically as part of the Downtown Specific Plan. From Wilson on the east to "C" street on the west, San Jacinto to the north and 11th Street to the south, there is a tremendous need for high density which would create a sense of place. This area would incorporate possibly 30-45 units per acre (density bonuses emphasized for landowners willing to invest in multi-family dwelling units). Development of the Perris owned theater as an entertainment venue along with a variety of cultural/ethnic restaurants would take advantage of the metro link/bus station, skydiving venue, Field of Dreams, and even a hotel to house skydivers, players attending Field of Dreams tournaments, Orange Railway events, and other sporting activities.

- B. Professional business development, which is virtually non-existent in this City. An example of a very good business project is the City of Riversides' Fairmount Business Park. This would be pursued primarily on Perris Boulevard in conjunction with all of the retail development.
- C. In lieu of previously designated Specific Plan areas such as the area east of the 215 Freeway South of San Jacinto, I would propose the largest fully accommodated public park in the area. The park would include a Community Center, lots of shade trees, a lake for boating (not fishing) lots of shaded picnic areas (example Whittier Narrows park in Whittier California). It is used for jogging, walking, picnics, lake boating events, etc... There would be nothing like it in the area, possibly a 30 to 45 acre or more park.
- D. Finally, it is my contention that City planning should focus on developing Economic Overlay Zones, particularly in main corridors such as the Ramona Expressway, and Perris Blvd that are in close proximity to the Lake Perris Recreation facility. An overlay zone would focus attention of attracting and developing entertainment and recreational developments such as hotels, a bowling alley, "sit-down" restaurants, theaters and possibly an IMAX theater. Perris would become not only be know for the "xtreme sports" but family fun and entertainment for all ages taking advantage of the attractions already in the City such as the Field of Dreams, the Southern California Railway Museum, the DropZone Water Park and Perris Skydiving. An overlay zone keeps in tact current zoning and works to establish developments that would enhance or compliment what already exists. This is particularly important as we face the 2028 Olympics at Lake Perris with no current hotel or family entertainment of any kind in the immediate area.

5. Other comments and/or ideas as to how you as a member of the Planning Commission could benefit the City of Perris?

- 1) I would say that I personally may not benefit but a suggestion is to have possibly (if logistically possible) one (1) or at maximum (2) meetings in community locations such as the VFW center, Field of Dreams auditorium, if weather permitting the amphitheater at Mercado Park, Senior Citizen/Teen Center, etc. Takes the efforts and information directly to the community.
- 2) As a community project, continue to enlist the community with overlays, scale models and other effects as to what physically they think various development types should look from a Hands-on perspective. Scale models of future D Street developments would be fun but also a way of involving the community in future development in a fun and engaging atmosphere.

Thank you for this opportunity to re-apply as a Planning Commissioner for the City of Perris. I look forward to serving again in the near future.
