WHEREAS, pursuant to Government Code § 7050, Girdhari S. Purohit and Shanti Purohit, as Trustees of the Girdhari S. and Shanti Purohit Family Trust Dated January 28, 1997, made irrevocable offers of dedication to the City of Perris ("City"), attached hereto as Exhibits "A," "B," and "C," of portions of APN 302-100-009 ("Property") located at the northeast corner of the Harley Knox Boulevard proposed extension and North Perris Boulevard, in the City of Perris, County of Riverside, State of California as more particularly described in the legal description attached to Exhibits A, B, and C, for street and highway improvement purposes (the "Offer"); and

- **Section 2.** The City Council hereby accepts the Offer for public street and highway improvements.
- Section 3. The City Clerk is hereby authorized and directed to cause a Certificate of Acceptance to be recorded on behalf of the City in the Office of the Riverside County Recorder, and to certify the adoption of this resolution. The Mayor, City Manager, and City Clerk are hereby authorized and directed to execute any and all other documents as may be necessary to effect the recordation of the Certificate of Acceptance and its enforcement.

LEGAL MAP


