A. Intention to Abate a Public Nuisance in the City of Perris, Located at 2217 Firebrand Ave, APN: 320101007. This intention to abate is to demand that Oscar Olvera (Property Owner) abate and/or remedy a public nuisance related property maintenance under the Perris Municipal Code PMC 7.06.030 (2), (5)(a), and (5)(b), and PMC 7.42.020 (b)(1)

**REQUESTED ACTION:** Approve Resolution No. 18-2, making findings and a determination of a public nuisance, ordering the Property Owner to abate the nuisance, and authorizing the City to commence abatement of such nuisance.

**B.** Ordinance Amendment 17-05214 – Proposal to amend Zoning Code Chapter 19.69 "Parking and Loading Standards" of the Perris Municipal Code to update the Multi-Family parking ratios for guest parking, studios, one-bedroom, two-bedroom, and three bed-room parking requirements.

**REQUESTED ACTION:** Adopt Resolution No. 17-21 recommending that City Council find the Ordinance Amendment categorically exempt from the California Environmental Quality Act (CEQA) guidelines pursuant to Section 15061(b)(3), and approve Ordinance Amendment 17-05214, based on the findings contained in the Resolution and attached exhibits.
