

### BACKGROUND/DISCUSSION:

The California Department of Housing and Community Development (the Department) announced the release of approximately \$141 million in funding for Transit-Oriented Development (TOD) Housing Program. The primary goal of the TOD Housing Program is to promote the use of public transit and to stimulate affordable housing developments near transit stations. Grapevine Development LLC, has expressed interest in partnering with the City for the D Street Downtown Revitalization Project and is proposing to submit a grant application to assist in the development of affordable for this project. Since the project sites are owned by the City of Perris, Grapevine Development is requesting a resolution by the City to authorize their grant application.

Grapevine is interested in using the TOD Grant funds to help fund construction of an affordable rental housing development project in the Downtown Specific Plan. The development project proposes a mixed-use development including units designated for affordable housing, which will contribute to meeting the City's required Regional Housing Needs Assessment (RHNA) figures. City staff is currently working with potential developers in the development of housing in downtown. One of those potential developers is Grapevine Development, LLC, which initially notified the City of the TOD Program grant opportunity. With approval of this Resolution, Grapevine Development, LLC will submit the application in a nonbinding agreement for use of the TOD Grant funds in Downtown Perris. However, an exclusive negotiations agreement has not been entered with Grapevine Development. If the City decides to move forward with Grapevine development, the TOD grant will be applied to the project if the grant is awarded.

Staff recommends that the City Council adopt the attached resolution: approving the submission of a grant application for the Transit-Oriented Development Housing Program by Grapevine Development, LLC.

WHEREAS, the City of Perris ("City") wishes to apply for and receive an allocation of funds through the TOD Program for the D Street Revitalization Project; and

WHEREAS the City of Perris is an Eligible Applicant under the TOD Program and wishes to apply for a TOD Program Grant in an amount not to exceed \$15,000,000 ("TOD Grant") to develop infrastructure in support of affordable housing ("TOD Project") under the above described NOFA.

NOW, THEREFORE, IT IS RESOLVED: That the City of Perris is hereby authorized and directed to act in connection with the Department's TOD Grant pursuant to the above-mentioned NOFA.

RESOLVED FURTHER: That in connection with the City's TOD Grant, Grapevine Development, LLC is authorized to submit the TOD Grant Application on behalf of the City of Perris; and the City of Perris is authorized and directed to enter into, execute, and deliver a State of California Standard Agreement, and any and all other documents required or deemed necessary or appropriate to carry into effect the full intent and purpose of the above resolution, in order to evidence the TOD Grant, the City's obligations related thereto, and the Department's security therefore; including, but not limited to, an affordable housing covenant, a performance deed of trust, a disbursement agreement, and certain other documents required by the Department as security for, evidence of or pertaining to the TOD Grant, and all amendments thereto (collectively, the "TOD Grant Documents").

RESOLVED FURTHER: That the Mayor of the City of Perris is hereby authorized to execute the TOD Grant Documents, and any amendment or modifications thereto, on behalf of the City of Perris.

### BACKGROUND/DISCUSSION:

On May 12, 2020, City Council approved the creation of the City of Perris Small Business Assistance Program, as part of the City's efforts to assist businesses during the COVID-19 pandemic. The initial allocation was approved for \$300,000 under the existing Community Economic Development Corporation (CEDC) budget. To date, a total of 53 applications have been received with 13 applications being approved, totaling to \$125,500 of expended program funds. There are currently 28 applications under review, requesting a total of \$279,165.00 with an available program funds balance of \$174,500. There were 12 applications denied because the applicants had already received CARES ACT funds and the City's loan program gives priority to businesses that did not receive any funds from the CARES ACT.

The City Council had previously directed staff to allocate an additional \$100,000.00 to the Small Business Assistance Program. The Economic Development subcommittee met on July 9, 2020, and after reviewing the most recent application increase, recommended that an additional \$100,000.00 be allocated to the program, totaling to \$200,000.00 of additional funds to the Small Business Assistance Program. This would bring the total budget for the Small Business Assistance Program to \$500,000.00 and provide opportunities for those businesses that did not receive at least \$10,000.00 in funds under the CARES ACT. The ED subcommittee also recommended that businesses who did not receive at least \$10,000.00 from the CARES ACT may apply for City of Perris assistance to close the gap up to a collective total of \$10,000 between the two funding sources.

Staff recommends that City Council approve the allocation of \$200,00.00 from the City's General Fund to the City of Perris Small Business Assistance Program.

BUDGET (or FISCAL) IMPACT: The allocation of \$200,000.00 will be drawn from City's General Fund 20/21.

### BACKGROUND/DISCUSSION:

In April, the old 15-inch pressure sewer in Case Road failed causing a large sinkhole. Due to the threat to public safety the road was closed while Eastern Municipal Water District (EMWD) made temporary sewer repairs and fixed the road. After further investigation, EMWD has discovered that H2S gas has corroded the pipeline, and that a 70-foot run of the sewer line must be replaced. A quick repair is critical for the City as 100% of its sewer service area drains through this pipeline. EMWD is requesting the closure of Case Road for up to two weeks (July 15-July 29) in order to make the repair with its own maintenance crews.

Engineering reviewed the site in the field with EMWD. Due to the narrowness of the road, the depth of the repair trench and its close proximity to the Case Road bridge, the need to cross traffic lanes to spoil material, the safety of both the public and EMWD's repair crew, and the importance of the repair to the City's own sewer system, Engineering recommends approval of the closure request.

While not ready at the time of staff report submittal, EMWD is preparing a Traffic Management and Detour Plan that will clearly depict the limits of the closure. Besides the usual barricades and detour signs, the detour plan will include multiple message boards to minimize the inconvenience of the closure to the public.

City staff recommends approval of the Case Road closure subject to issuance of a City Encroachment Permit, and proper notification of City Inspectors, local emergency responders, schools, etc. Such notice shall be available on the City's social media/webpage.
