RESOLUTION NUMBER 5407

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA, RECITING THE FACTS OF THE CONSOLIDATED GENERAL ELECTION (GENERAL MUNICIPAL ELECTION) HELD IN SAID CITY ON NOVEMBER 6, 2018, DECLARING THE RESULTS THEREOF AS TO THE ELECTION OF CITY COUNCIL MEMBERS AND THE CITY CLERK AND SUCH OTHER MATTERS AS PROVIDED BY LAW

WHEREAS, a regular consolidated general election was held and conducted in the City of Perris, California, on Tuesday, November 6, 2018, as required by law; and

WHEREAS, notice of said election was duly and regularly given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects said election was held and conducted and the votes cast thereat, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Election Code of the State of California for the holding of elections in cities; and

WHEREAS, pursuant to Resolution Number 5272 adopted on May 29, 2018, the Riverside County of Registrar of Voters canvassed the returns of said election and has certified the results to this City Council, and said results are received, attached and made a part hereof as Exhibit "A";

NOW, THEREFORE, the City Council of the City of Perris does hereby **RESOLVE**, **DECLARE**, **DETERMINE** and **ORDER** as follows:

- Section 1. That there were 18 voting precincts established for the purpose of holding said election consisting of consolidations of the regular election precincts in the City as established for the holding of state and county elections.
- Section 2. That said regular general municipal election was consolidated with other elections being held in the same territory, with the same voters and held on the same date pursuant to Section 10400 of the Elections Code.
- Section 3. That said regular general municipal election was held for the purpose of electing the following officers of said City, in addition for the purpose of considering certain measures, as required by laws relating to cities in the State of California, to wit:

Two Members of the City Council of said City for a full term of four years.

One City Clerk of said City for a full term of four years.

Section 4. That the whole number of votes cast at each precinct in said City was 4083 and the whole number of vote by mail ballots cast in said City was 8175, making a total of 12258 votes cast in said City.

That the names of persons voted for at said election for Member of the City Council of said City of Perris were as follows:

David Starr Rabb Raul M. Ruiz Blanca Lopez Brady A. McCarron Marisela Magana

That the names of persons voted for at said election for City Clerk of said City of Perris were as follows:

Maya Rodriguez Nancy Salazar

That the number of votes given at each precinct and the number of votes given in the City to each of such persons above named for the respective offices for which said persons were candidates are as listed in Exhibit "A" attached.

Section 5. Based upon Exhibit "A," the City Council does declare and determine that:

David Starr Rabb was elected as Member of the City Council of said City for a full term of four years.

Marisela Magana was elected as Member of the City Council of said City for a full term of four years.

Nancy Salazar was elected as City Clerk of said City for a full term of four years.

Section 6. Pursuant to Elections Code 10264, and attached as Exhibit "A", the City Clerk shall enter on the records of the City Council of said City, a statement of result of said election showing:

The whole number of votes cast in the City; The names of the persons voted for; For what office each person was voted for; The number of votes given at each precinct to each person, The number of votes given in the city to each person.


Section 7. That the City Clerk shall immediately make and deliver to each of such persons so elected a Certificate of Election signed by the City Clerk and duly authenticated; that the City Clerk or designee shall also administer to each person elected, the Oath of Office prescribed in the State Constitution of the State of California and shall have them subscribe thereto, and shall file the same in the Office of the City Clerk. Whereupon, each and all of said persons so elected shall be inducted into the respective office to which they have been elected.

Section 8. That the City Clerk shall certify to the passage and adoption of this Resolution; shall enter the same in the book of original Resolutions of said City; and shall make a minute of passage and adoption thereof in the records of the proceeding of the City Council of said City, in the minutes of the meeting at which the same is passed and adopted.





Riverside County, Registrar of Voters CODE OF FAIR CAMPAIGN PRACTICES

(Elections Code § 20440)



There are basic principles of decency, honesty, and fair play which every candidate for public office in the State of California has a moral obligation to observe and uphold in order that, after vigorously contested but fairly conducted campaigns, our citizens may exercise their constitutional right to a free and untrammeled choice and the will of the people may be fully and clearly expressed on the issues.

THEREFORE:

- (1) I SHALL CONDUCT my campaign openly and publicly, discussing the issues as I see them, presenting my record and policies with sincerity and frankness, and criticizing without fear or favor the record and policies of my opponents or political parties that merit this criticism.
- (2) SHALL NOT USE OR PERMIT the use of character defamation, whispering campaigns, libel, slander, or scurrilous attacks on any candidate or his or her personal or family life.
- (3) I SHALL NOT USE OR PERMIT any appeal to negative prejudice based on a candidate's actual or perceived race, religious creed, color, national origin, ancestry, physical disability, mental disability, medical condition, marital status, age, sexual orientation, sex, including gender identity, or any other characteristic set forth in Section 12940 of the Government Code, or association with another person who has any of the actual or perceived characteristics set forth in Section 12940 of the Government Code.
- (4) I SHALL NOT USE OR PERMIT any dishonest or unethical practice that tends to corrupt or undermine our American system of free elections, or that hampers or prevents the full and free expression of the will of the voters including acts intended to hinder or prevent any eligible person from registering to vote, enrolling to vote, or voting.
- (5) I SHALL NOT coerce election help or campaign contributions for myself or for any other candidate from my employees.
- (6) I SHALL IMMEDIATELY AND PUBLICLY REPUDIATE support deriving from any individual or group that resorts, on behalf of my candidacy or in opposition to that of my opponent, to the methods and tactics that I condemn. I shall accept responsibility to take firm action against any subordinate who violates any provision of this code or the laws governing elections.
- (7) I SHALL DEFEND AND UPHOLD the right of every qualified American voter to full and equal participation in the electoral process.

I, the undersigned, candidate for election to public office in the State of California or treasurer or chairperson of a committee making any independent expenditures, hereby voluntarily endorse, subscribe to, and solemnly pledoe-myself to conduct my campaign in accordance with the above principles and principles.
