The City Attorney's Office spoke with the Planning Department and they are in the process of working towards the revocation of the marijuana permit for Dynamic Meds. I will continue to follow-up.
06/27/2020 07:54:45 AM	Parker, John	06/27/2020	On 06/25/2020 the City Attorney's Office wanted to know if Dynamic Meds at 4605 Wade Ave has a valid medical marijuana dispensary permit. Per the Planning Department, Dynamic Meds submitted for a medical marijuana dispensary permit with Planning and were approved. They were required to obtain a Certificate of Occupancy prior to obtaining a business license. This is when Planning would verify that all conditions were met before signing off. The Planning Department stated that there is an associated site modification application that requires the site improvements. Attached is the comment letter for the site modification and also the approval for the dispensary license. I will continue to follow-up.

The Business License Department stated that they would send the letter to HDL to start the revocation process of the business license since it was obtained prior to receiving approval and prior to receiving a certificate of occupancy.

I will continue to follow-up.

Since there is no Certificate of Occupancy and no progress made to obtain one, a business license cannot be issued. The City Attorney's Office will work on proceeding with a civil action. Once Riverside Superior Court has re-opened, they will get all necessary documents filed ASAP. I will continue to follow-up.

The Planning Manager Kenneth Phung stated that we need to proceed with steps to close the operation until they obtain the necessary approval to open whether that's temporary occupancy or permanent occupancy. Supervisor Trejo stated and he agreed with the Planning Manager Kenneth Phung. The City Attorney's Office was asked to schedule a hearing and proceed with the next steps of criminal or civil action against the property owner until their operation is closed or until they obtain approval to open with the Planning Department. After speaking with the Business License Department and the Planning Department it appeared that Dynamic Meds obtained a Business License without permission from the City of Perris. Dynamic Meds worked with HDL business license processing and through some gray area found a way to obtain a business license. Dynamic Meds did not obtain a Certificate of Occupancy as their counsel stated in their email. Per the Planning Department, Dynamic Meds are not permitted to operate until they complete their off-site improvements or obtain a temporary occupancy permit. I spoke with

Supervisor Trejo and he informed me that he would look into possibly revoking Dynamic Meds business license since it was issued in error. The Business License Department reached out to HDL informing them that the City of Perris has an open case against Dynamic Meds at 4605 WADE ST. For all marijuana-based, in-city business, no license should be or have been issued prior to obtaining a Certificate of Occupancy from the Development Services and providing a copy at the time of business license application. The Business License Department requested HDL to assist with the case by providing all the supporting documents submitted by Dynamic Meds at the time of the application. Per Supervisor Trejo, the City Attorney's Office was informed that the City of Perris would like to proceed with enforcement actions against this property/business. The City Attorney's Office informed me that I they would reach out to the property owners counsel with this information and once they hear back, they will advise and proceed accordingly. On 01-23-2020 starting at 9:00 p.m. I will (with the assistance of Sheriff's Deputies) conduct inspections at all dispensaries and issue NOV's for all dispensaries operating past 9:00 p.m. NOV's will be hand delivered to staff with a follow up date of 01-24-2020. I will follow up with inspection findings on 01-24-2020.
