RESOLUTION NUMBER 5485

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS. COUNTY **OF** RIVERSIDE, **STATE** OFAMENDING, CALIFORNIA, ESTABLISHING, **AND** ADOPTING FEES FOR SERVICES PROVIDED BY THE **PUBLIC** DEPARTMENT, **WORKS** ANIMAL CONTROL DIVISION PURSUANT TO AND AUTHORIZED BY ORDINANCE NUMBER 1380

- **WHEREAS**, Title 8, "Animals," of the Perris Municipal Code regulates animals within the City of Perris; and
- **WHEREAS**, the City Council has adopted Ordinance Number 1380 on the 14th day of May, 2019, which amends Title 8, "Animals," of the Perris Municipal Code in its entirety such that the City's animal regulations are updated and revised; and
- **WHEREAS**, Ordinance Number 1380 further provides for the collection of fees relating to the provision of animal control services by the City and also provides that such fees shall be set by the City Council; and
- **WHEREAS**, the City Council has determined that the administrative fees, which are attached hereto as Exhibit "A" and incorporated herein by this reference, reasonably relate to the City's cost for the provision of animal control services pursuant to Ordinance Number 1380.
- **NOW, THEREFORE, BE IT RESOLVED,** by the City Council of the City of Perris, California, as follows:
- **Section 1.** That the recitals set forth above are true and correct and incorporated herein by this reference.
- **Section 2.** That, pursuant to Ordinance Number 1380, the City Council hereby amends, establishes, and adopts administrative fees for animal control services pursuant to Ordinance Number 1380 as set forth in the attached Exhibit A, with such fees being effective on the 1st day of August, 2019.
- **Section 3.** That any prior administrative fee specifically adopted by the City Council as part of the prior Title 8 of the Perris Municipal Code (i.e., those regulations that are now superseded by Ordinance Number 1380), are hereby repealed to the extent that such fees conflict with the administrative fees amended, established, and adopted by this Resolution.
- **Section 4.** That the City Clerk shall certify to the passage and adoption of this Resolution and enter it into the book of original Resolutions. This Resolution shall be effective immediately upon passage and adoption.
