### **RESOLUTION NUMBER 5653**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS, APPROVING AN AMENDMENT TO THE CITIZEN PARTICIPATION PLAN, A SUBSTANTIAL AMENDMENT TO THE 2019-2024 CONSOLIDATED PLAN AND FY 2019-2020 ANNUAL ACTION PLAN TO INCLUDE FUNDING FROM THE CORONAVIRUS AID, RELIEF, AND ECONOMIC SECURITY ACT (CARES ACT) COMMUNITY DEVELOPMENT BLOCK GRANT CORONAVIRUS (CDBG-CV) ALLOCATION

**WHEREAS**, the City of Perris received \$536,986 from the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) for Community Development Block Grant Coronavirus (CDBG-CV) funding to be used to prevent, prepare for, and respond to the COVID-19 (coronavirus) pandemic; and

*WHEREAS*, the City of Perris, pursuant to Federal regulations has solicited public input to the amended 2019-2024 Consolidated Plan, FY 2019-2020 Annual Action Plan, and Citizen Participation Plan to include programmatic funding of the CDBG-CV funds in the amount of \$536,986; and

**WHEREAS**, on April 28, 2028, the City Council conducted a duly noticed public hearing in which it accepted public input and considered the amendments to the 2019-2024 Consolidated Plan, FY 2019-2020 Annual action Plan, and Citizen Participation Plan; and

**WHEREAS**, the approvals herein are final for the amended Citizen Participation Plan and inclusions of the CDBG-CV funds in the 2019-2024 Consolidated Plan, FY 2019-2020 Annual Action Plan; and

WHEREAS, the 2019-2024 Consolidated Plan, FY 2019-2020 Annual Action Plan, and Citizen Participation Plan are planning documents and are not subject to the California Environmental Quality Act (CEQA) as they would not result in a direct or reasonably foreseeable physical change in the environment pursuant to State CEQA Guidelines 15060 (c)(2) nor considered a project pursuant to State CEQA Guidelines 15060 (c)(3).

**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Perris, as follows:

- **Section 1.** The recitals set forth above are true and correct, and incorporated herein by this reference.
- **Section 2.** That the City Council has determined that the 2019-2024 Consolidated Plan, FY 2019-2020 Annual Action Plan, and Citizen Participation Plan are planning documents and are not subject to CEQA pursuant to Sections 15060 (c)(2) and 15060 (c)(3).

**Section 3.** That the City Council hereby approves the amended Citizen Participation Plan and inclusion of the CDBG-CV funds in the 2019-2024 Consolidated Plan and FY 2019-2020 Annual Action Plan.

**Section 4.** That the City Council authorizes the City Manager, or his designee, to take all necessary and appropriate actions to carry out this Resolution, including, but not limited to, submitting the amendment to the Citizen Participation Plan, 2019-2024 Consolidated Plan and FY 2019-2020 Annual Action Plan to the Department of Housing and Urban Development; executing all documents related to the Citizen Participation Plan, 2019-2024 Consolidated Plan and FY 2019-2020 Annual Action Plan; and any related administration thereof, for the following:

- 1. The addition of \$536,986 in CDBG-CV funds to the 2019-2024 Consolidated Plan and FY 2019-2020 Annual Action Plan to allow for the Rental, Mortgage and Utility Assistance Programs; and
- 2. Amending the public review and comment period from 30-days to 5-days as allowed by HUD guidance issued on April 9, 2020 in order to expedite procedures and implementation of CDBG-CV funds.

**Section 5.** That the City Clerk shall attest and certify to the passage of this resolution and it shall thereupon take effect and be in full force.

# **Executive Summary**

### Introduction

On March 27, 2020 Congress passed the Coronavirus Aid, Relief, and Economic Security Act or the "CARES Act". The Act identified additional funding for the Community Development Block Grant (CDBG) to support preparation for and response to the community impacts of the COVID-19 pandemic. HUD's distribution plan for the additional funding included multiple phases that would allow for quick access to funding necessary to address the immediate crisis resulting from the rising pandemic, as well as phases that would support post-pandemic community recovery. This Consolidated Plan includes planning for both phases. The CARES Act was passed after the public participation for this Consolidated Plan was substantially complete. CARES Act funding plans were presented for public comment as part of the public comment period of the Consolidated Plan.

The needs in this chapter were derived from preliminary data from the impacts of COVID-19 which indicate a worsening of existing needs. Public services, including nutrition support and health care, housing assistance, particularly for households suffering loss of income, support for persons experiencing homelessness, and economic development support for businesses impacted by forced closure are key programmatic needs that have been identified in the CARES Act.

### **Needs Assessment**

### **NA-05 Overview**

#### **Needs Assessment Overview**

The needs previously identified in this Consolidated Plan focused on housing, homelessness prevention and response, economic development, public services, and public facilities and infrastructure. The COVID-19 pandemic has only exacerbated needs already existing in our communities. However, some needs have been reprioritized.

The ongoing shut-down of businesses has resulted in record unemployment, which severely impacts areas with a higher cost of living and areas already impacted by higher poverty rates. Small businesses have been especially impacted as many do not have the working capital to weather months of mandated shut-down while maintaining payrolls and employment benefits.

As a result of shortages in some areas, combined with loss of income for many households, there has been substantial increase in demand for assistance through public services, especially food banks, meal delivery services, and healthcare-related services. The rapid increase in demand has left many service providers under-staffed and under-resourced and has added substantial cost. The increased demand is expected to be sustained beyond the shut- down as households will take time to regain employment and economic stability.

Homelessness response and homelessness prevention has also risen in priority. Many households have been unable to pay rent since the shut-down and shelter-in-place orders were issued in early March 2020. While there are moratoriums on evictions, housing costs are still a major concern, particularly for lower-income households who may be at risk of homelessness once the moratorium is lifted. Homelessness prevention must be a community priority to prevent increase in homelessness as housing protections are lifted. Persons already experiencing homelessness are also at increased risk of infection and death due to COVID-19.

# AP-50 Geographic Distribution – 91.220(f)

Introduction

As permitted in the CARES Act, HUD has elected to waive the federal caps on public services for services that are in response to COVID-19 impacts. The City of Perris will be required to document that the services funded through CDBG-CV are in response to COVID-19. Any services provided that are not in response to COVID-19 will be subject to the federal 15 percent public services cap.

This method of distribution is expected to facilitate immediate fund utilization and improve emergency response to critical community needs resulting from the COVID-19 pandemic.
