

RESOLUTION NUMBER 5655

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS, APPROVING THE FY 2020-2021 ACTION PLAN WITH PROPOSED FUNDING FOR THE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FEDERAL ENTITLEMENT PROGRAM

WHEREAS, the City of Perris, pursuant to 24 CFR 91.200 (d) and 91.220 (b), developed a FY 2020-2021 Action Plan that coordinates all elements of planned community development in the City to include housing, neighborhood development, economic development, and public services; and

WHEREAS, the City of Perris, pursuant to Federal regulations, has solicited public input on the Draft FY 2020-2021 Annual Action Plan which includes proposed funding in the amount of \$912,828 worth of CDBG related program and that were reviewed and approved by a City Council appointed CDBG sub-committee; and

WHEREAS, On April 14, 2020, the City Council approved preliminary funding recommendations for the FY 2020-2021 Annual Action Plan; and

WHEREAS, On April 28, 2020, the City Council considered the FY 2020-2021 Annual Action Plan for the CDBG Federal Entitlement Program; and

WHEREAS, the approvals herein are final for inclusion in the FY 2020-2021 Annual Action Plan; and

WHEREAS, the FY 2020-2021 Action Plan as planning document is not subject to the California Environmental Quality Act (CEQA) as they would not result in a direct or reasonably foreseeable physical change in the environment pursuant to State CEQA Guidelines 15060 (c)(2) nor considered a project pursuant to State CEQA Guidelines 15060 (c)(3).

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Perris, as follows:

SECTION 1. That the City Council has determined that the FY 2020-2021 Annual Action Plan as planning documents are not subject to CEQA pursuant to Sections 15060 (c)(2) and 15060 (c)(3).

SECTION 2. That the City Council hereby approves the FY 2020-2021 Annual Action Plan for the CDBG Federal Entitlement Program.

SECTION 3. That the City Clerk shall attest and certify to the passage of this resolution and it shall thereupon take effect and be in full force.
