## RESOLUTION NUMBER 5766

## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS, CALIFORNIA, SETTING PARKING VIOLATION FEES

- **WHEREAS** Vehicle Code Section 22507 authorized the City to prohibit or restrict the stopping, parking, or standing of vehicles on certain streets or highways, or portions thereof during all or certain hours of the day; and
- **WHEREAS**, the City of Perris has enacted ordinances regulating the parking of vehicles in the City of Perris; and
- **WHEREAS**, Vehicle Code Section 22507 requires that the City Council shall set forth the specific penalties which will be levied for violations of ordinances regulating parking in the City; and
- *WHEREAS*, on December 27, 1993 the City Council adopted Resolution No. 2338 setting parking violation fees; and
- *WHEREAS*, on January 31, 2017 the City Council adopted Resolution No. 5081 creating a 2-hour time limit for parking on D Street; and
- **WHEREAS**, the Resolution No. 2338 does not include a parking violation fee for time limited parking; and
- **WHEREAS**, concurrent with this resolution the City Council also considered an amendment to the Perris Municipal Code adding Section 10.24.210 Parking Time Limits on Certain Street; and
- *WHEREAS*, the ordinance amending the Perris Municipal Code adding Section 10.24.210 Parking Time Limits on Certain Street established a 2-hour limited parking zone on D Street between San Jacinto Avenue and Eighth Street; and
- *WHEREAS*, the penalties set by the City Council in this resolution are comparable to those of nearby cities as required in Government Code Section 22507.
- NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF PERRIS, CALIFORNIA, DOES HEREBY RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:
- <u>Section 1.</u> Recitals. The recitals set forth above are true and correct and incorporated herein by this reference.
- **Section 2.** Parking Violation Penalty Schedule Amended. The table below is amended to include a fee for violating time limited parking restrictions.
