- A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA, ADOPTING A LIST OF PROJECTS FOR FISCAL YEAR 2024-25 FUNDED BY SB 1: THE ROAD REPAIR AND ACCOUNTABILITY ACT OF 2017
- WHEREAS, Senate Bill 1 (SB 1), the Road Repair and Accountability Act of 2017 (Chapter 5, Statutes of 2017) was passed by the Legislature and Signed into law by the Governor in April 2017 to address the significant multi-modal transportation funding shortfalls statewide; and
- **WHEREAS**, SB 1 includes accountability and transparency provisions that will ensure the residents of our City are aware of the projects proposed for funding in our community and which projects have been completed each fiscal year; and
- **WHEREAS**, the City must adopt by resolution a list of projects proposed to receive fiscal year funding from the Road Maintenance and Rehabilitation Account (RMRA), created by SB 1, which must include a description and the location of each proposed project, a proposed schedule for the project's completion, and the estimated useful life of the improvement; and
- *WHEREAS*, the City, will receive an estimated \$2,020,465.00 in RMRA funding in Fiscal Year 2024-25 from SB 1; and
- **WHEREAS**, this is the ninth year in which the City is receiving SB 1 funding and will enable the City to continue essential road maintenance and rehabilitation projects, safety improvements, repairing and replacing aging bridges, and increasing access and mobility options for the traveling public that would not have otherwise been possible without SB 1; and
- **WHEREAS**, the City has undergone a robust public process to ensure public input into our community's transportation priorities/the project list; and
- **WHEREAS**, the City used a Pavement Management System to develop the SB 1 project list to ensure revenues are being used on the most high-priority and cost-effective projects that also meet the communities priorities for transportation investment; and
- **WHEREAS**, the funding from SB 1 will fund the Annual Slurry Seal and Street Grind and Overlay Program throughout the City this year and subsequent Annual Slurry Seal and Street Grind and Overlay Projects into the future; and
- **WHEREAS**, the 2021 California Statewide Local Streets and Roads Needs Assessment found that the City streets and roads are at higher risk condition (PCI 50-60) and this revenue will help the City increase the overall quality of our road system and over the next decade will bring our streets and roads into a good condition; and
- **WHEREAS**, the SB 1 project list and overall investment in our local streets and roads infrastructure with a focus on basic maintenance and safety, will result in improved infrastructure

that attempts on utilizing cutting-edge technology, materials and practices, while also addressing American with Disabilities Act, achieving local, regional, and statewide benefits.

NOW, THEREFORE IT IS HEREBY RESOLVED, by the City Council of the City of Perris, State of California, as follows:

Estimated Project Schedule: May 2025 – Completion October 2025

Estimated Project Useful Life: 10 Years

Section 3. The following previously adopted projects may also utilize Fiscal Year 2024-25 Road Maintenance and Rehabilitation Account revenues in their delivery. With the relisting of these projects in the adopted fiscal year resolution, the City is reaffirming to the public and the State our intent to fund these projects with Road Maintenance and Rehabilitation Account revenues:
