

URGENCY ORDINANCE NUMBER 1298

***AN URGENCY ORDINANCE OF THE CITY COUNCIL OF
THE CITY OF PERRIS ENACTED PURSUANT TO
CALIFORNIA GOVERNMENT CODE §§ 36934 AND 36937
REPEALING ORDINANCE NO. 1294 REGARDING A
CHANGE OF ELECTION DATES***

WHEREAS, on July 9, 2013, the City Council of the City of Perris duly adopted Ordinance No. 1294 changing the election date for the City of Perris from even-numbered year elections to odd-numbered year elections; and

WHEREAS, although Ordinance No. 1294 became effective upon adoption, it will not be operative until approved by the Riverside County Board of Supervisors; and

WHEREAS, the County Board of Supervisors has indicated that the Board is not inclined to approve Ordinance No. 1294; and

WHEREAS, the City Council desires to repeal Ordinance No. 1294 and continue holding elections in even-numbered years, and to make such repeal immediate to save expenses that may be incurred by the County in considering Ordinance No. 1294; and

WHEREAS, pursuant to Sections 36934 and 36937 of the California Government Code, the City may adopt an urgency ordinance if it is for the immediate preservation of the public peace, health or safety.

NOW, THEREFORE, the City Council of the City of Perris, California hereby ordains as follows:

Section 1. Recitals. The above recitals are true and correct and are hereby incorporated herein by reference.

Section 2. Repeal of Ordinance No. 1294. Ordinance No. 1294 is hereby repealed. Chapter 2.57 of the Perris Municipal Code shall remain in full force and effect as stated prior to Ordinance No. 1294. General municipal elections shall be held on the first Tuesday after the first Monday of November in even-numbered years.

Section 3. Effectiveness of Ordinance. This Urgency Ordinance shall be effective immediately upon adoption pursuant to the authority conferred upon the City Council by California Government Code Section 36937.

Section 4. Urgency Findings. The City Council finds and determines that adoption of this Ordinance is for the immediate preservation of the public peace, health and safety, as those terms are defined in California Government Code Section 36937(b).

Section 5. Authority. This urgency ordinance is enacted pursuant to the authority conferred upon the City Council by Government Code §§ 36934 and 36937, and shall be in full force and effect immediately upon its adoption by a four-fifths (4/5) vote of the City Council.

Section 6. Severability. If any section, subsection, sentence, clause, or phrase of this ordinance is for any reason held to be invalid or unconstitutional by a decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this ordinance. The City Council hereby declares that it would have passed this ordinance, and each and every section, subsection, sentence, clause and phrase thereof not declared invalid or unconstitutional without regard to whether any portion of the ordinance would be subsequently declared invalid or unconstitutional.

Section 7. Certification. The City Clerk shall certify as to the passage and adoption of this Ordinance and shall cause the same to be posted at the designated locations in the City of Perris.
