

**ORDINANCE NUMBER 1180**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF PERRIS, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA, APPROVING A NEGATIVE DECLARATION (2203), PRE-ZONE 05-0231 TO APPLY THE ZONING DESIGNATION OF R-7,200 ON APPROXIMATELY 27 ACRES OF LAND ON THE NORTHEAST CORNER OF PLACENTIA AVENUE AND EL NIDO AVENUE, AND AUTHORIZING THE CITY MANAGER TO EXECUTE A PLAN FOR SERVICES TO INITIATE THE ANNEXATION PROCESS, AND MAKING FINDINGS IN SUPPORT THEREOF**

**WHEREAS**, the City Council adopted a Zoning Ordinance establishing zoning designations and development standards for the City of Perris; and

**WHEREAS**, said proposal is consistent with General Plan Amendment 05-0415; and

**WHEREAS**, on December 7, 2005, the Planning Commission conducted duly noticed public hearings on the proposed Rezoning, considered testimony and materials in the staff report and accompanying documents, and recommended approval of the proposed project; and

**WHEREAS**, on January 31, 2006, the City Council conducted a duly noticed public hearing on the proposed projects, considered testimony and materials in the staff reports, accompanying documents and exhibits; and

**WHEREAS**, the City Council reviewed the Plan for Services for the propose project and determined the document to be adequate and complete; and

**WHEREAS**, the City Council considered and approved the Initial Study and Negative Declaration (2203) for the project, finding that these documents adequately addressed the impacts of the proposed project, were prepared in accordance with the California Environmental Quality Act, and reflected the independent judgment of the City; and

**WHEREAS**, all legal prerequisites for the adoption of this resolution have occurred;

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Perris, California, as follows:

**Section 1.** The above recitals are all true and correct.

**Section 2.** The City Council has reviewed and considered the environmental documentation for the project prior to taking action on the applications. Based on the analysis contained in the Initial Study and the accompanying environmental information, the City Council finds that:

- A. There is no substantial evidence of potentially significant environmental impacts and a Negative Declaration (2203) has been prepared.
- B. The City has complied with the California Environmental Quality Act (CEQA).
- C. Determinations of the Planning Commission reflect the independent judgment of the City.

**Section 3.** Based on the information contained within the Project Report and the accompanying attachments and exhibits, the City Council hereby finds that:

- A. The proposed Pre-Zone is consistent with the General Plan Amendment 05-0415 and with existing General Plan objectives, policies and programs.
- B. The proposed Pre-Zone is compatible with adjoining land uses and will not adversely affect the public health, safety and welfare.
- C. The proposed Pre-Zone Change will not result in a significant adverse effect on the environment.

**Section 4.** The City Council hereby amends the Zoning Map (PRE-ZONE 05-0231) based on the information and findings presented in the staff report, dated January 31, 2006.

**Section 6.** The City Council hereby authorizes the City Manager to execute a Plan for Services to initiate the annexation process.

**Section 7.** The City Council declares that should any provision, section, paragraph, sentence, or word of this Resolution be rendered or declared invalid by any court of competent jurisdiction, or by reason of any preemptive legislation, the remaining provisions, sections, paragraphs, sentences and words of this Ordinance shall remain in full force and effect.

**Section 8.** The Mayor shall sign this Ordinance and the City Clerk shall certify to the passage and adoption of this Ordinance, and shall cause the same to be published and posted pursuant to the provisions of law in this regard, and this Ordinance shall take effect thirty days after its final passage.
