

ORDINANCE NUMBER 1113

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF PERRIS, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA, APPROVING AN AMENDMENT TO AN APPROVED DEVELOPMENT AGREEMENT BETWEEN THE CITY OF PERRIS AND KB HOME COASTAL, INC. FOR DEVELOPMENT OF THE MAY RANCH SPECIFIC PLAN LOCATED SOUTH OF RAMONA EXPRESSWAY BETWEEN THE PERRIS VALLEY STORM DRAIN AND RIDER STREET AT THE INTERSECTION OF RAMONA EXPRESSWAY, AND NORTH OF PLACENTIA AVENUE (DEVELOPMENT AGREEMENT 03-0067)

WHEREAS, KB Home Coastal, Inc., the applicant, has requested an amendment to an approved Development Agreement for development of the May Ranch Specific Plan, a 743-acre master plan community consisting of 2,945 single-family detached homes and 375 multi-family homes with an overall density of 4.5 dwelling units to the acre, with 38.7 acres set aside for park plan and 68.8 acres set aside for commercial land; and

WHEREAS, on March 11, 2003, the City Council conducted a legally, noticed public hearing on the Development Agreement and considered testimony and materials in the staff report and accompanying document and exhibits; and,

WHEREAS, on March 19, 2003, the Planning Commission conducted a legally, noticed public hearing and determined that “the provision of the development agreement are consistent with the general plan and any applicable specific plan (May Ranch Specific Plan)” pursuant to California Government Code Section 65867.5. (b) of the Planning and Zoning Law; and

WHEREAS, the City has complied with the California Environmental Quality Act; and,

WHEREAS, all legal prerequisites for the adoption of this Ordinance have occurred;

NOW, THEREFORE, THE CITY COUNCIL HEREBY ORDAINS AS FOLLOWS:

Section 1. The above recitals are all true and correct.

Section 2. The City Council has reviewed and considered the information and determined that the proposed Development Agreement will not have a significant adverse effect on the environment in that the previously Mitigated Negative Declaration No. 2108 approved by the City Council on May 28, 2002, adequately addressed the impacts of the proposed project and no new information or impacts have been identified that would require a subsequent or

supplemental Environmental Impact Report or Negative Declaration. Therefore, pursuant to Section 15162 of the California Environmental Quality Act Guidelines the project does not require any further environmental review or Negative Declaration.

Section 3. The City Council ***HEREBY FINDS AND DETERMINES THAT:***

- A. The proposed Development Agreement is consistent with the applicable General Plan objectives, policies, general land uses, and programs.
- B. The proposed Development Agreement is compatible with the uses authorized in, and the regulations prescribed for, the land use district in which the real property is located.
- C. The proposed Development Agreement is in conformity with and will promote public convenience, general welfare and good land use practice.
- D. The proposed Development Agreement will not be detrimental to the health, safety and general welfare.
- E. The proposed Development Agreement will not adversely affect the orderly development of the property or the preservation of property values.
- F. The proposed Development Agreement will promote and encourage the development of the proposed project by providing a greater degree of requisite certainty.

Section 4. Approval. The Development Agreement, a copy of which is attached hereto as Exhibit "A", is hereby approved. The Mayor and City Clerk are authorized to execute and deliver the proposed Development Agreement on behalf of the City.

Section 5. Recording. Pursuant to California Code Section 65858.5, the City Clerk shall record with the County Recorder of the County of Riverside a copy of the Development Agreement within ten (10) days after the Agreement is executed on behalf of the City and KB Home Coastal, Inc.

Section 6. The Mayor shall sign and the City Clerk shall certify passage and adoption of this Ordinance, and shall cause the same to be published and posted pursuant to the provisions of law in this regard, and this Ordinance shall take effect thirty days after its final passage.
