

ORDINANCE NUMBER 978

*AN URGENCY ORDINANCE EXTENDING INTERIM URGENCY ORDINANCE NUMBER 975 OF THE CITY COUNCIL OF THE CITY OF PERRIS, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA AMENDING CHAPTER 14.08, SECTIONS 14.08.020, 14.08.030, 14.08.040, 14.08.060 AND 14.08.090 TO INCREASE WATER RATES, RESCINDING SECTION 14.08.050 OF THE PERRIS MUNICIPAL CODE AND REPEALING ORDINANCE NUMBER 969*

*WHEREAS*, the Water Department of the City of Perris purchases all of its water from Eastern Municipal Water District ("EMWD") for its water users; and

*WHEREAS*, on April 1, 1993, Metropolitan Water District ("MET") increased its domestic water rate from \$322.00 to \$385.00 for each acre foot (an increase of 16-2/3%); and

*WHEREAS*, EMWD which purchases most of its water from MET, increased its wholesale water rate from \$84.75 to \$98.00 for each acre foot effective January 1, 1994, for a total wholesale rate of \$483.00 per acre foot; and

*WHEREAS*, Perris must increase its water rates to its water customers to offset EMWD's rate increase of 16-2/3% by increasing the consumption charge by 16-2/3%, rather than increasing the monthly service charge; and

*WHEREAS*, Government Code Section 36937 permits this City Council to adopt as an urgency measure, interim authorization which shall be effective for a period of thirty (30) days for the increase in water rates when necessary to respond to a current and immediate threat to the public health, safety and welfare which shall take effect immediately, if such measure contains findings describing the current and immediate threat to the public health, safety and welfare that exists in the absence of such an interim measure; and

*WHEREAS*, Interim Urgency Ordinance Number 975 was adopted by the City Council on January 31, 1994, changing the water rates and other water service charges and fees; and

*WHEREAS*, as Interim Urgency Ordinance Number 975 expires in a 30 day period, this Council may enact an additional interim urgency ordinance to allow the

Water Department of the City to collect the increase in water rates for an additional thirty (30) day period until such time as permanent Ordinance Number 976 is effective; and

*WHEREAS*, this urgency ordinance extending Interim Ordinance Number 975 is needed to respond to a current and immediate threat to the public safety and welfare if enacted by a four-fifths vote of the Council; and

*WHEREAS*, this Council deems it to be in the best interests of the residents of the City of Perris that this urgency ordinance be enacted to avoid paying to EMWD increased water charges from the City's general fund which is necessary to pay for the City police services and other vital City services.

*WHEREAS*, the City Council, ten days prior to expiration of Interim Urgency Ordinance Number 975 has reviewed the facts and issues addressed therein and has issued a full report describing the measures taken to alleviate the conditions which led to the adoption of the ordinance.

*NOW, THEREFORE*, the City Council of the City of Perris does ordain the following:

*SECTION 1.* Section 14.08.020 of the Perris Municipal Code is hereby amended to read as follows:

*"14.08.020 Domestic Users.* The monthly service charge for domestic users shall be as follows:

In the event consumption on the 3/4" service is four hundred cubic feet or less the monthly service charge shall be \$9.10. Water consumption charge shall be \$1.32 per one hundred cubic feet."

*SECTION 2.* Section 14.08.030 of the Perris Municipal Code is amended to read as

follows:

*"14.08.030 Commercial and Industrial Users, including hotels and motels.* The monthly service charge for commercial and industrial users shall be as follows:

In the event consumption on the three-quarter-inch service is four hundred cubic feet or less the monthly service charge shall be \$9.10. Water consumption charge shall be \$1.32 per one hundred cubic feet.

*SECTION 3.* Section 14.08.040 of the Perris Municipal Code is amended to read as follows:

*14.08.040 Multiple-Family Units.* Multiple-family units (two or more units) and other customers served from one water meter, excluding hotels and motels shall be billed the monthly service charge according to meter size, plus an additional unit charge of \$11.90 for each unit above one.

Water consumption charge shall be \$1.32 per one hundred cubic feet. The adjusted water consumption charge in Sections 1, 2 and 3 shall become effective February 15, 1994.

*SECTION 4.* Section 14.08.060 is amended to read as follows:

*"14.08.060 Rates -- Increase of Decrease.* The rates set forth in this Chapter shall be increased or decreased by a Resolution, which shall be subject to a public hearing prior to adoption, and approved by a four-fifths vote of the City Council.

*SECTION 5.* Section 14.08.050 is hereby rescinded.

*SECTION 6.* Section 14.08.090 of the Perris Municipal Code is amended to read as follows:

*14.08.090 Water Meter Installation Charges.*

*SECTION 7.* Ordinance Number 969 is hereby repealed.

*SECTION 8.* This Council hereby finds that the City's general fund is committed to the funding of City police services and other vital City services, and without enactment of this Urgency Ordinance the City would have to commit such funds to the payment of water charges to EMWD which would cause a decrease in funding adequate levels police service and other vital City services, thereby creating a current and immediate threat to the public health, safety and welfare of the residents of the City of Perris.

*SECTION 9.* Interim Urgency Ordinance Number 975 is hereby extended for a period of thirty (30) days.

*SECTION 10.* The City Clerk shall certify to the adoption of this Ordinance and cause it, or a summary of it, to be published once in a newspaper of general circulation within the City of Perris.
