ORDINANCE NUMBER 993

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF PERRIS, CALIFORNIA, REPEALING SECTION 2.36.030 OF THE PERRIS MUNICIPAL CODE REGARDING COMPOSITION AND ADMINISTRATION OF THE PARK AND RECREATION COMMISSION

WHEREAS, the City Council of the City of Perris has recently amended policies for Commissions.

NOW, THEREFORE, the City Council of the City of Perris does hereby ordain as follows:

SECTION 1. Section 2.36.030 is hereby repealed.

SECTION 2. Section 2.36.030 is hereby added to the Perris Municipal Code as follows:

Section 2.36.030 Composition and Administration of the Park and Recreation Commission:

- A. The Park and Recreation Commission shall be made up of five (5) members as appointed by the Mayor by and with consent of the City Council. The appointees should have experience and knowledge of park and recreation design, management, and/or other skills which would benefit the Commission in performing it's duties.
- B. Alternates: Appointed Commission members shall not have alternates.
- C. Terms: The term of each appointed member of the Commission shall be for four (4) years, with the three of the initial members appointed to two (2) year terms.
- D. Quorum: Any three (3) Park and Recreation Commission members shall constitute a quorum for the purpose of conducting business.
- E. Public Meetings:
 - 1. All Park and Recreation Commission meetings shall be conducted as public meetings pursuant to Government Code Section 54950 et seq.
 - 2. The Park and Recreation Commission may, at its discretion, set items for public hearings. The following noticing procedures shall be complied with

for any items which are set as hearing items:

- (a) publish in a local newspaper of general circulation
- (b) post at City Hall
- 3. The Park and Recreation Commission may continue items from time to time as it deems appropriate.
- F. Decisions of the Park and Recreation Commission: The Park and Recreation Commission shall act as an advisory board to the City Council. All decisions of the Park and Recreation Commission which require legislative approval shall be forwarded to the City Council for final action. All other decisions made by the Park and Recreation Commission may be presented to the City Council for final action if the Council requests.
