

ORDINANCE NUMBER 1004

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF PERRIS, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA DISSOLVING THE BOARD OF ZONING ADJUSTMENT AND THE PARK AND RECREATION COMMISSION AND TRANSFERRING CERTAIN DUTIES TO THE PLANNING COMMISSION OF THE CITY OF PERRIS

WHEREAS, on May 26, 1992 the City Council of the City of Perris (the "City Council") established the Board of Zoning Adjustment (the "BZA") by adopting Ordinance Number 901 for the purpose of designating it to hear and review the City's nuisance abatement cases; and

WHEREAS, the BZA consists of five (5) regular members selected by the City Council; and

WHEREAS, on March 29, 1993 the City Council of the City of Perris established the Park and Recreation Commission (the "Park and Recreation Commission") by adopting Ordinance Number 949 for the purpose of reviewing all Park master plans, design and construction drawings to ensure compliance with Park classification requirements and standards for the Park land use, space, size and facility architectural quality; and

WHEREAS, the Park and Recreation Commission consists of five (5) members appointed by the City Council; and

WHEREAS, the City Council established the Planning Commission of the City of Perris (the "Planning Commission") pursuant to Government Code Section 65100 et seq to act as a permanent advisory committee to review matters related to land use planning and development matters; and

WHEREAS, the Planning Commission consists of five (5) members; and

WHEREAS, the City Council desires to reduce the number of City boards and commissions in the interest of decreasing City costs involved in staffing and maintaining the various City boards and commissions; and

WHEREAS, to accomplish this, the City Council recognizes that the duties of the BZA and the Park and Recreation Commission involve advising it, in essence, on land use matters, and

WHEREAS, the City Council desires to dissolve the BZA and the Park and Recreation Commission and transfer all of the BZA duties and certain Park and Recreation

Commission duties to the Planning Commission.

NOW, THEREFORE, the City Council of the City of Perris does ordain as follows:

Section 1. The Board of Zoning Adjustment (the "BZA") of the City of Perris is hereby dissolved thereby rescinding Ordinance Number 901.

Section 2. The Park and Recreation Commission (the "Park and Recreation Commission") of the City of Perris is hereby dissolved thereby rescinding Ordinance Number 949.

Section 3. All duties of the BZA defined in the Perris Municipal Code Chapter 19.77 are hereby transferred to the Planning Commission of the City of Perris (the "Planning Commission").

Section 4. All duties regarding review of the Park master plan, design and construction as formerly provided by the Park and Recreation Commission are transferred to the Planning Commission.

Section 5. All terms of the existing Planning Commissioners of the City of Perris are hereby terminated as of the effective date of this Ordinance. The date for commencement of new terms of the Planning Commission pursuant to Section 2.32.020 of the Perris Municipal Code, shall be set by Resolution of the City Council.

Section 6. The Mayor shall sign and the City Clerk shall certify to the passage and adoption of this Ordinance and shall cause the same to be published and posted pursuant to the provisions of law in this regard, and this Ordinance shall take effect thirty (30) days after its passage.
