

ORDINANCE NUMBER 1032

*AN URGENCY ORDINANCE OF THE CITY COUNCIL OF THE CITY OF PERRIS, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA, INCREASING SEWER RATES FOR SERVICES PROVIDED BY EASTERN MUNICIPAL WATER DISTRICT (EMWD)*

*NOW THEREFORE, BE IT RESOLVED*, by the City Council of the City of Perris does ordain as follows:

*Section 1.* The City Council of the City of Perris does hereby find, determine and declare that:

A. The City Council of the City of Perris, County of Riverside, California, through its adoption of Ordinance Number 579 established regulations governing the imposition of certain water and sewer equity fees to provide for the proper maintenance and operation of said sewer system; and

B. The City of Perris receives sewage treatment and reclamation services from the Eastern Municipal Water District; and

C. The cost of providing these services increase periodically which requires an increase in rates charged.

D. Sewer treatment and reclamation cost increases have been incurred by EMWD since January 1996.

E. The following sewer rates will be effective with the May 15, 1996 billing period:

1. For each residential service a monthly increase to \$14.57 per month.
2. For all other classifications, excluding schools, charges shall be the following:  
\$.0132 per 100 cubic feet of water used per month.
3. For each school located on the property to be served, rate per student shall be the following:

and employee per month	Preschool/Elementary	\$0.00335 per student, teacher
and employee per month	Middle/Junior High	\$0.00479 per student, teacher
and employee per month	High School/College	\$0.00665 per student, teacher

*Section 2.* It is necessary for the immediate preservation of the public peace, health and safety that this Ordinance take effect immediately to protect public safety, preserve the economic viability of the community and to ensure that the character of the community is preserved. This Ordinance is hereby declared to be an urgency measure and shall take effect immediately upon its adoption. The statement of facts constituting the bases for the urgency hereof is as above set forth.

*Section 3.* The Mayor shall sign and the City Clerk shall certify to the passage and adoption of this Ordinance and shall cause the same to be published and posted pursuant to the provisions of law in this regard, and this Ordinance shall take effect immediately and be in full force and effect until repealed by the City Council.
