

ORDINANCE NUMBER 1035

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF PERRIS, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA, AMENDING REFUSE COLLECTION CHARGES AND RESCINDING ORDINANCE 983

WHEREAS, the City Council of the City of Perris adjusts the Solid Waste Collection and Disposal Rates (the "Rates") by ordinance; and

WHEREAS, an adjustment to the rates is made to reflect any increase in the Consumer Price Index (the "CPI") and/or any increase in Landfill Tipping Fees; and

WHEREAS, an increase in the Rates is warranted at this time due to an increase in the CPI last year of 2.0%; and

WHEREAS, the Rates are charged on a monthly basis becoming a civil debt owing to the City or the City's exclusive franchisee for the collection and disposal of solid waste services City's agent in this instance, by the owner and any occupant or user of the premises receiving said service.

NOW, THEREFORE, the City Council of the City of Perris does ordain as follows:

Section 1. Section 7.16.055 of the Perris Municipal Code is hereby amended to read as follows:

"Section 7.16.055 Collection and Disposal Monthly Rates and Charges"

1. A monthly charge for rubbish collection, transfer and disposal services is hereby levied upon each occupied household and business establishment, in accordance with the following rates:

(a) Residential

(1) Single family residences, mobile homes, apartments, condominiums, townhouse, bungalow courts, and multiple residences per dwelling unit, using 100 gallon individual receptacles.

Monthly rate: \$ 15.24

- (2) Single family residences, mobile homes, apartments, condominiums, townhouse, bungalow courts, and multiple residences per dwelling unit, using 60 gallon individual receptacles.

Monthly rate: \$ 11.94

- (b) Commercial and Industrial

- (1) Individual receptacles

Once per week pick up: \$ 15.74

- (c) Commercial, Industrial, and Multiple Residences

- (1) Two cubic yard container

1 x per week	\$ 82.13
2 x per week	149.31
3 x per week	216.49
4 x per week	283.67
5 x per week	350.85
6 x per week	418.03

- (2) Three cubic yard container

1 x per week	\$ 95.81
2 x per week	174.90
3 x per week	253.99

6 x per week	491.26

- (d) Other

- (1) 10 to 40 cubic yard roll-off container (permanent)

\$ 126.40 + landfill,

transfer and
franchise fee

- (2) 10 cubic yard roll-off
container (temporary 8 ton maximum) \$ 510.00 per load

- 40 cubic yard roll-off
container (temporary 6 ton maximum) \$ 416.00 per load

Section 2. This ordinance supersedes Ordinance Number 1036 upon its effective date.

Section 3. The Mayor shall sign this Ordinance and the City Clerk shall certify to the passage of this Ordinance and shall cause it to be published and posted pursuant to state law.

Section 4. This Ordinance shall be effective thirty days after its passage.
