

ORDINANCE NUMBER 1040

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF PERRIS, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA, EXTENDING INTERIM URGENCY ORDINANCE NUMBER 1039 TO PROHIBIT THE ESTABLISHMENT OF ANY METHADONE CLINIC OR OTHER SIMILAR MEDICAL TREATMENT/SERVICE FACILITY DURING THE PENDENCY OF THIS ORDINANCE FOR THE PURPOSE OF STUDY AND EXAMINATION

WHEREAS, the City Council of the City of Perris adopted Ordinance Number 1039 prohibiting the establishment of any methadone clinic or other similar medical treatment/service facility uses so that the Department of Planning and Community Development could review the definitions, regulations and impacts of methadone clinics or other similar medical treatment/service facility uses on the orderly growth of the City or on the public health, safety, morals and welfare; and

WHEREAS, after reviewing this matter, the Department of Planning and Community Development is desirous of conducting a study of the establishment of any methadone clinic or other similar medical treatment/service facility uses for the foregoing reasons; and

WHEREAS, the City Council is desirous of extending Interim Urgency Ordinance Number 1039 to allow the Department of Planning and Community Development additional time to complete said study.

NOW, THEREFORE, the City Council of the City of Perris does ordain as follows:

Section 1. The Department of Planning and Community Development will conduct a complete study of the establishment of methadone clinics or other similar medical treatment/service facilities on the orderly growth of the City or on the public health, safety, morals and welfare.

Section 2. Interim Urgency Ordinance Number 1039 is extended for a period of ten (10) months and fifteen (15) days pursuant to California Government Code Section 65858.

Section 3. The City Council finds, determines and declares that the above recitals are true and correct. The City Council shall incorporate the recitals herein and hereby finds that this Ordinance is required to prevent a current and immediate threat to the public health, safety and welfare and that the City needs to thoroughly study the impacts of methadone clinics and other similar medical treatment/service facilities uses and how such uses will affect the public health, safety and welfare including the economic viability peace and morals of the community.

The approval of said uses during pendency of the City's evaluation and study would result in an immediate threat to the public health, safety or welfare.

Section 4. The Ordinance shall take effect immediately upon the expiration of Interim Urgency Ordinance Number 1039 and shall remain in effect until ten (10) months and fifteen (15) days have expired.

Section 5. This Ordinance was heard at a legally noticed City Council meeting and it was approved by a four-fifths (4/5) vote of the City Council.

Section 6. The Mayor shall sign and the City Clerk shall certify to the passage and adoption of this Ordinance and shall cause the same to be published and posted pursuant to the provisions of law in this regard.
