

**RESOLUTION NUMBER 5229**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA, IN SUPPORT OF SENATE BILL NUMBER 1192 WHICH SUPPORTS CHILDREN'S HEALTH BY ENSURING HEALTHY BEVERAGES ARE THE DEFAULT OPTIONS IN CHILDREN'S MEALS IN RESTAURANTS**

**WHEREAS**, on March 14, 2017, the City Council of the City of Perris ("City Council") adopted Ordinance Number 1340 requiring food establishments in the City of Perris to provide a healthy beverage as the default beverage in children's meals; and

**WHEREAS**, Chapter 7.48 - DEFAULT BEVERAGES OFFERED IN CHILDREN'S MEALS was added to the City of Perris Municipal Code; and

**WHEREAS**, the purpose was and is to support children's health by requiring healthy beverages to be offered as the default beverage included with restaurant children's meals. Default beverages such as water, milk, and 100% juice; and

**WHEREAS**, the cities of Davis, Stockton, Berkeley, Long Beach, Cathedral City, Daly City, Chula Vista, Hawthorne, and the counties of San Francisco and Santa Clara passed ordinances and resolutions similar to the City of Perris; and

**WHEREAS**, California State Senator William Monning has authored Senate Bill ("SB") No. 1192 (2018) to add Health & Safety Code Section 114092 to further the healthy default beverages in children's meals policy at the state level; and

**WHEREAS**, the City Council's support of SB 1192 will further promote and facilitate healthier lifestyles, for which the City of Perris has become a regional leader; and

**WHEREAS**, the Administrative Services Department, studied this matter in February 2018 and forwarded the recommendation to the City Council to adopt a resolution demonstrating its support of SB 1192.

**NOW, THEREFORE**, City Council of the City of Perris hereby ordains, as follows:

**Section 1.** The above recitals are all true and correct and are incorporated herein as if set forth in full.

**Section 2.** That this Council supports the adoption of legislation that expands the policy of requiring healthy default beverages in children's meals.

**Section 3.** That, upon passage of this Resolution, the City Clerk shall deliver this Resolution to the Honorable William Monning, California State Senator of the 17<sup>th</sup> District and the City of Perris would go on record in support of the Bill.
