

RESOLUTION NUMBER 5081

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA, ESTABLISHING TIME LIMITED PARKING ON "D" STREET BETWEEN SAN JACINTO AVENUE AND FOURTH STREET

WHEREAS, the City Council of the City of Perris ("City") has identified a need for time limited parking on "D" Street between San Jacinto Avenue and Fourth Street; and

WHEREAS, California Vehicle Code Section 22507 authorizes the City to prohibit or restrict the stopping, parking, or standing of vehicles on certain streets or highways, or portions thereof, during all or certain hours of the day; and

WHEREAS, on December 20, 2016, City staff contacted various businesses which would be affected by the proposed time limited parking along "D" street between San Jacinto Avenue and Fourth Street; and

WHEREAS, on January 31, 2017, the City Council reviewed and considered the proposed time limited parking on "D" Street between San Jacinto Avenue and Fourth Street, as provided further in Exhibit A of this Resolution; and

WHEREAS, the City Council has determined that the establishment of time limited parking on "D" Street between San Jacinto Avenue and Fourth Street serves the public interest by providing reasonable parking for businesses located on "D" Street and for the customers and visitors of such businesses; and

WHEREAS, the City Council desires to establish time limited parking on "D" Street between San Jacinto Avenue and Fourth Street, as provided further in Exhibit A.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF PERRIS DOES HEREBY RESOLVE AS FOLLOWS:

Section 1. The foregoing recitals are incorporated herein as if set forth in full

Section 2. The City Council does hereby authorize and order the establishment of time limited parking on "D" Street between San Jacinto Avenue and Fourth Street, as more particularly described in Exhibit A of this Resolution.

Section 3. The City Manager and City Engineer are hereby authorized to purchase and install the appropriate signs required by state and local law to implement and enforce the time limited parking as provided in this Resolution, up to the amount budgeted from time to time for this purpose.

Section 4. The City Clerk shall certify as to the adoption of this Resolution.
