

RESOLUTION NUMBER 5121

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS AMENDING RUBBISH COLLECTION CHARGES AS PERMITTED IN SECTION 7.16.050 (D) OF THE PERRIS MUNICIPAL CODE AND RESCINDING RESOLUTION NUMBER 5015.

WHEREAS, the Consumer Price Index has increased by 2.68%; and the County of Riverside has increased their landfill tipping fees by 1.97%; and

WHEREAS, said increase is necessary to defray these costs by increasing the rates and charges to the recipient of such services; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Perris as follows:

Section 1. Pursuant to 7.16.050 (D) of the Perris Municipal Code, the rates and charges of Chapter 7.16 are adjusted as follows:

“Section 7.16.050 Rubbish Collection, Disposal and Street Sweeping”

1. A monthly charge for rubbish collection, transfer, disposal and street sweeping services is hereby levied upon each occupied household and business establishment, in accordance with the following rates:

(a) Residential

(1) Single family residences, mobile homes, apartments, condominiums, town homes, bungalow courts, and multiple residences per dwelling unit, using 100 gallon individual receptacles.

Monthly Rate: \$27.63

(2) Single family residences, mobile homes, apartments, condominiums, town homes, bungalow courts, and multiple residences per dwelling unit, using 60 gallon individual receptacles.

Monthly Rate: \$22.53

(3) Additional 100 gallon individual receptacles.

Monthly Rate: \$ 9.50

(4) Additional 60 gallon individual receptacles.

Monthly Rate: \$ 8.22

(b) Commercial and Industrial

(1) Individual receptacles

Once per week pick up: \$29.37

(c) Commercial, Industrial, and Multiple Residences

(1) Two cubic yard container	1 x week	\$136.87

	4 x week	\$498.09
	5 x week	\$618.53
	6 x week	\$738.90

(2) Three cubic yard container	1 x week	\$157.51

(d) Other

(1) 10 to 40 cubic yard roll-off container \$224.97 + MRF/Landfill fees

(e) Street Sweeping Services

(1) Weekly Commercial, Arterial and Downtown Area

(2) Bi-weekly Residential Area

Included in the Rates listed above.

Rates for residential customers (Section 1(a)) shall become effective January 1, 2018. Rates for all other customers (Commercial; Industrial; Other Large Receptacles) shall become effective July 1, 2017.

Section 2. Resolution Number 5015 is hereby rescinded per the effective dates stated in Section 1.
