- A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS, APPROVING THE FY 2017-2018 ACTION PLAN WITH PROPOSED FUNDING FOR THE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FEDERAL ENTITLEMENT PROGRAM
- **WHEREAS**, the City of Perris, pursuant to Federal regulations, and has solicited public input on the FY 2017-2018 Annual Action Plan with proposed funding; and
- **WHEREAS**, the City of Perris, after due consideration and review, has complied with the necessary Federal, State and local regulations and requirements; and
- WHEREAS, On March 28, 2017, the City Council considered community development and housing needs and approved preliminary CDBG funding recommendations for the FY 2017-2018 Action Plan; and
- **WHEREAS**, on July 11, 2017, the City Council held a public hearing to solicit input on the FY 2017-2018 Action Plan.
- **NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Perris, as follows:
- <u>SECTION 1.</u> That the City Council approves the recommended funding amounts for projects funded under the Federal CDBG Entitlement Program as indicated in Exhibit A.
- <u>SECTION 2</u>. That the City Council hereby authorizes adding the recommended funding amounts to the Action Plan to be submitted to the Department of Housing and Urban Development (HUD) for FY 2017-2018 for the Federal Entitlement Program.
- <u>SECTION 3.</u> That the City Council authorizes adding the D. Street Area Enhancements- Open Space/Public Plazas and the Citywide Sidewalk and Pedestrian Ramps Installation non-public service projects to the Fiscal Year 2017-2018 Capital Improvement Program budget.
- <u>SECTION 4.</u> That the City Council authorizes the City Manager, or his designee, to execute all documents related to the Fiscal Year 2017-2018 CDBG Entitlement Program.
- <u>SECTION 5</u>. That the City Clerk shall attest and certify to the passage of this resolution and it shall thereupon take effect and be in full force.
