

**RESOLUTION NUMBER 4683**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA, AUTHORIZING THE LOCATION, FUNDING OF CONSTRUCTION AND MAINTENANCE OF AN ENTRY MONUMENT TOWER AT THE I-215 AND D STREET INTERCHANGE IN THE CITY OF PERRIS**

**WHEREAS**, the City of Perris desires to mark entrance into the City at a key location, and;

**WHEREAS**, the City of Perris has considered all available locations for monumentation of entry into the City of Perris, and;

**WHEREAS**, Interstate 215 is the major thoroughfare through the City of Perris and the primary entrance into the City of Perris, and;

**WHEREAS**, the City has exhaustively sought available options for monument locations outside of State right of way and deemed all potential options to be infeasible, and;

**WHEREAS**, the City of Perris holds sole jurisdiction over the area around D Street outside of Caltrans right-of-way along Interstate 215, and;

**WHEREAS**, the City of Perris desires to solely fund construction and maintenance of a monument tower at the interchange of D Street and Interstate 215 in compliance with Caltrans Gateway Monument Program, and;

**WHEREAS**, the City of Perris shall apply for an encroachment permit from Caltrans for Construction of said monument tower, and;

**WHEREAS**, the City of Perris will commence construction as soon as approval by Caltrans and the Federal Highways Administration is received by the City for construction of the monument per Caltrans "Gateway Monument Guidelines" and the Caltrans Encroachment Permit is issued for construction, and construction duration shall be approximately 100 calendar days.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Perris, as follows:

**Section 1.** The above recitals are all true and correct.

**Section 2.** The Mayor shall sign and the City Clerk shall certify to the passage and adoption of this Resolution.
