## **RESOLUTION NUMBER 4788**

A SUPPLEMENTAL RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS ADJUSTING THE DATE OF PUBLIC HEARING REGARDING FORMATION AND OTHER MATTERS RELATING TO PROPOSED COMMUNITY FACILITIES DISTRICT NO. 2014-2 (PERRIS VALLEY SPECTRUM) OF THE CITY OF PERRIS

WHEREAS, on October 14, 2014, pursuant to Resolution No. 4776 (the "Resolution of Intention for Formation") of the City Council of the City of Perris determined to institute proceedings for the formation of a community facilities district pursuant to the terms and provisions of the Mello-Roos Community Facilities Act of 1982, as amended, being Chapter 2.5, Part 1, Division 2, Title 5 of the Government Code of the State of California (the "Act"), to be named "Community Facilities District No. 2014-2 (Perris Valley Spectrum) of the City of Perris" (the "Proposed District"), and setting a public hearing as required by the Act for November 25, 2014, at 6:00 PM or as soon thereafter as practicable; and

**WHEREAS**, on October 14, 2014, pursuant to Resolution No. 4777 (the "Resolution of Intention to Issue Bonds"), the City determined to institute proceedings for the issuance of bonded indebtedness, in order to finance the facilities of the Proposed District, and set a public hearing as required by the Act for November 25, 2014, at 6:00 PM or as soon thereafter as practicable; and

WHEREAS, the City Council may reschedule its meeting of November 25, 2014; and

**WHEREAS**, on October 28, 2014, pursuant to Resolution No. 4782, the City supplemented the Resolution of Intention to Issue Bonds and the Resolution of Intention for Formation to include a new date for public hearing of December 9, 2014; and

**WHEREAS**, the Council now desires to reschedule the public hearing date from December 9, 2014, to January 13, 2015, and desires to amend and supplement the Resolution of Intention for Formation, and the Resolution of Intention to Issue Bonds, accordingly; and

**WHEREAS**, all actions required prior to approval of the items described herein have been taken and the Resolution of Intention for Formation, and the Resolution of Intention to Issue Bonds, shall remain in effect and are supplemented hereby.

*NOW*, *THEREFORE*, THE CITY COUNCIL OF THE CITY OF PERRIS DOES HEREBY RESOLVE AS FOLLOWS:

- **Section 1.** The above recitals are true and correct.
- **Section 2.** The first sentence of Section 8 of the Resolution of Intention for Formation, as supplemented by Section 2 of Resolution No. 4782, is hereby amended to state:

A public hearing (the "Hearing") on the establishment of Community Facilities District No. 2014-2, the proposed rate and method of apportionment of the Special Tax and the proposed issuance of bonds to refinance the Facilities and the Incidental Expenses shall be held on January 13, 2015, at 6:00 p.m., or as soon thereafter as practicable, at the chambers of the City Council of the City of Perris, 101 North "D" Street, Perris, California 92570.

**Section 3.** The remaining provisions of the Resolution of Intention for Formation shall remain unchanged, and the City Clerk is hereby directed to publish a notice of the public hearing at least seven (7) days prior to the date of the public hearing, in accordance with the Resolution of Intention for Formation and the Act.

**Section 4.** Section 5 of the Resolution of Intention to Issue Bonds, as supplemented by Section 4 of Resolution 4782, is hereby amended to state:

A public hearing (the "Hearing") on the proposed debt issue shall be held on January 13, 2015, at 6:00 p.m. or as soon thereafter as practicable, at the chambers of the City Council of the City of Perris, 101 North "D" Street, Perris, California 92570.

**Section 5.** The remaining provisions of the Resolution of Intention to Issue Bonds shall remain unchanged, and the City Clerk is hereby directed to publish a notice of the public hearing in accordance with the provisions of the Resolution of Intention to Issue Bonds, at least seven (7) days prior to the date of the public hearing, in accordance with the Resolution of Intention to Issue Bonds and the Act.

**Section 6.** This resolution shall take effect and be enforceable immediately upon its adoption.
