

**RESOLUTION NUMBER 4592**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS AMENDING RUBBISH COLLECTION CHARGES AS PERMITTED IN SECTION 7.16.050 (D) OF THE PERRIS MUNICIPAL CODE AND RESCINDING RESOLUTION NUMBER 4502.**

**WHEREAS**, the Consumer Price Index has increased by 1.29%; and the County of Riverside has increased their landfill tipping fees by 1.89; and

**WHEREAS**, said increase is necessary to defray these costs by increasing the rates and charges to the recipient of such services; and

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Perris as follows:

**Section 1.** Pursuant to 7.16.050 (D) of the Perris Municipal Code, the rates and charges of Chapter 7.16 are adjusted as follows:

“Section 7.16.050 Rubbish Collection, Disposal and Street Sweeping”

1. A monthly charge for rubbish collection, transfer, disposal and street sweeping services is hereby levied upon each occupied household and business establishment, in accordance with the following rates:

(a) Residential

(1) Single family residences, mobile homes, apartments, condominiums, town homes, bungalow courts, and multiple residences per dwelling unit, using 100 gallon individual receptacles.

Monthly Rate: \$26.11

(2) Single family residences, mobile homes, apartments, condominiums, town homes, bungalow courts, and multiple residences per dwelling unit, using 60 gallon individual receptacles.

Monthly Rate: \$21.23

(3) Additional 100 gallon individual receptacles.

Monthly Rate: \$ 9.05

(4) Additional 60 gallon individual receptacles.

Monthly Rate: \$ 7.83

(b) Commercial and Industrial

(1) Individual receptacles

Once per week pick up: \$23.15

(c) Commercial, Industrial, and Multiple Residences

(1) Two cubic yard container 1 x week \$128.74

2 x week \$241.62

3 x week \$354.50

4 x week \$467.41

5 x week \$580.31

6 x week \$693.17

(2) Three cubic yard container 1 x week \$148.38

2 x week \$279.02

3 x week \$409.68

4 x week \$540.32

5 x week \$670.98

6 x week \$801.61

(d) Other

(1) 10 to 40 cubic yard roll-off container \$209.98 + MRF/Landfill fees

(e) Street Sweeping Services

(1) Weekly Commercial, Arterial and Downtown Area

(2) Bi-weekly Residential Area

Included in the Rates listed above.

These rates shall become effective July 1, 2013.

**Section2.** Resolution Number 4502 is hereby rescinded.
