

RESOLUTION NUMBER 4462

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
PERRIS, COUNTY OF RIVERSIDE, STATE OF
CALIFORNIA, ADOPTING A WATER SERVICE
ADJUSTMENT FOR PASS THROUGH WATER CHARGES
FROM EASTERN MUNICIPAL WATER DISTRICT**

WHEREAS, the City manages and supplies the water enterprise of the City (the "System") by charging for water service provided to the residents of the City pursuant to Chapter 14.08 of the Perris Municipal Code, as such charges are adjusted from time to time by resolution; and

WHEREAS, the City is proposing to adjust its water rates in response to the Eastern Municipal Water District (EMWD) rate adjustment "pass through" by increasing their wholesale water rate sold to the City for "Treated Water" by 5.8%.; and

WHEREAS, City of Perris Municipal Code Section 14.08.060 permits the City Council to adopt water rate adjustments by resolution; and

WHEREAS, the City is permitted to pass through these water rate adjustments to consumers pursuant to Ordinance No. 1259 adopted on July 14, 2009 following a public hearing pursuant to Article XIII D of the California Constitution; and

WHEREAS, on January 13, 2012 or thereafter, the City will mail the Notice of Water Fee Adjustment to each property owner or customer subject to the fee along with the water bill, to be in effect for the February 15 – March 15, 2012 water bill to be mailed in April 2012, relating to and describing the water adjustment in accordance with applicable law to the applicable customers and/or parcels; and

WHEREAS, the increase shall commence at least 30 days following such mailing or a date thereafter (on February 15, 2012);

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Perris, California, as follows:

Section 1. The foregoing recitals are true and correct and incorporated herein by reference.

Section 2. The Council has fully considered this matter and has:

- A. Reviewed the submittal, notice and the information submitted herewith regarding the proposed increases, the parcels to which the proposed fee increase would apply, and the reasons and basis for the increase and the fees;

- B. Provided for notice of the proposed fee increase to the record owners (or renters/customers responsible for payment of the fee) of all parcels to which the proposed fee increase would apply in accordance with applicable law;
- C. Heard and received all objections, protests, or other written communications from any owners (or renters) of real property subject to the fee;
- D. Taken and received oral and documentary evidence pertaining to the proposed fee increase; and
- E. Been fully informed of this matter.

Section 3. That based on these facts and circumstances presented and the information received, the City Council finds that adjustments in water rates are necessary and the adjustments in accordance with the City of Perris Municipal Code Section 14.08.060 and Ordinance No. 1259, are hereby approved. The increases are shown on Exhibit A hereto and by this reference incorporated herein.

Section 4. Adjustments to Monthly Water Rates. Pursuant to Section 14.08.060 permitting changes in rates by Resolution, the water consumption rate for Tier One Customers set forth in Municipal Code Sections 14.08.020, 14.08.030, 14.08.040, 14.08.060, as said rates may have been adjusted pursuant to prior resolutions and/or ordinances, are increased as set forth below.

Monthly Water Consumption Charge. The water consumption charge (as measured by the monthly meter reading) based on the amount of hundred cubic feet of consumption (“hcf”) shall be as follows with respect to meter size for all customers serviced by the City’s Downtown Municipal System:

Meter Size	Current	New rate
5/8" – 1 " (0 - 18 hcf)	\$2.407	\$2.547
5/8" – 1" (over 18 hcf)*	\$5.155	\$5.155
1-1/2" – 2" (0 - 100 hcf)	\$2.407	\$2.547
1-1/2"- 2" (over 100 hcf)*	\$5.155	\$5.155
3" – 4" (0 - 300 hcf)	\$2.407	\$2.547
3" – 4" (over 300 hcf)*	\$5.155	\$5.155
6" (0 - 3600 hcf)	\$2.407	\$2.547
6" (over 3600 hcf)*	\$5.155	\$5.155

Section 5. The rate shall take effect for the February 15 – March 15, 2012 water bill to be mailed in April 2012, with the increase to be effective at least 30 days following the mailing of the notice.

Section 6. The City Clerk shall certify as to the adoption of this Resolution.
