

**RESOLUTION NUMBER 4497**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS,  
APPROVING THE FY 2012-2013 ACTION PLAN WITH PROPOSED  
FUNDING FOR THE COMMUNITY DEVELOPMENT BLOCK GRANT  
(CDBG) FEDERAL ENTITLEMENT PROGRAM**

**WHEREAS**, the City of Perris, pursuant to Federal regulations, and has solicited public input on the FY 2012-13 Action Plan with proposed funding; and

**WHEREAS**, the City of Perris, after due consideration and review, has complied with the necessary Federal, State and local regulations and requirements; and

**WHEREAS**, On April 10, 2012, the City Council considered community development and housing needs and reviewed preliminary CDBG funding recommendations for the FY 2012-13 Action Plan; and

**WHEREAS**, on May 8, 2012, the City Council held a public hearing to solicit public input on the FY 2012-13 Action Plan.

**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Perris, as follows:

**SECTION 1.** That the City Council approves the recommended funding amounts for projects funded under the Federal CDBG Entitlement Program as indicated in Exhibit A.

**SECTION 2.** That the City Council hereby authorizes adding the recommended funding amounts to the Draft Action Plan to be submitted to the Department of Housing and Urban Development (HUD) for FY 2012-13 for the Federal Entitlement Program.

**SECTION 3.** That the City Council authorizes the City Manager, or his designee, to execute all documents related to the Fiscal Year 2012-13 CDBG Entitlement Program.

**SECTION 4.** That the City Clerk shall attest and certify to the passage of this resolution and it shall thereupon take effect and be in full force.
