

**RESOLUTION NUMBER 4390**

***A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS APPROVING A SUBSTANTIAL AMENDMENT TO THE FIVE YEAR CONSOLIDATED PLAN (2009-2014) TO AMEND THE “EXECUTIVE SUMMARY SECTION, THE “STRATEGIC PLAN” SECTION (SECTION 5) AND THE “SUMMARY OF FIVE YEAR NEEDS AND OBJECTIVES TEXT AND REQUIRED TABLES” SECTION (SECTION 6) TO REVISE VARIOUS HOUSING, PUBLIC SERVICE AND COMMUNITY DEVELOPMENT GOALS, AND THEIR ASSOCIATED ANNUAL AND FIVE YEAR CUMULATIVE NUMERICAL OBJECTIVES IN ORDER TO CREATE A MORE BALANCED STRATEGY THAT IS COMMENSURATE WITH AVAILABLE RESOURCES***

**WHEREAS**, the City Council must approve substantial amendments to the City’s Five-Year Consolidated Plan, anytime the City proposes to alter its housing goals or objectives or its non-housing goals or objectives; and

**WHEREAS**, the City Council is proposing to amend the strategy, goals and objectives outlined in the Five-Year Consolidated Plan, including various Housing, Public Service and Community Development goals, so that they correspond with available resources; and

**WHEREAS**, pursuant to Federal Regulations at 24 CFR Part 91.105 (a)(3), and the City’s Citizen Participation Plan, a combined 30-day notice of the hearing and notice of public comment on the proposed amendment to the City’s Consolidated Plan was published in the Perris Progress Newspaper on March 3, 2011.

**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Perris, California as follows:

**SECTION 1.** That on April 12, 2011, the City Council conducted a duly noticed public hearing to receive public comment on the proposed amendment to the City’s Consolidated Plan to amend the Executive Summary, “Strategic Plan” Section (Section 5) and the “Summary of Five Year Needs and Objectives Required Tables” Section (Section 6) to revise various Housing, Public Service and Community Development goals, and their associated annual and five year cumulative numerical objectives in order to create a more balanced strategy that is commensurate with available resources.

**SECTION 2.** That, upon concluding the public hearing, the City Council hereby approves the substantial amendment to the City’s Consolidated Plan, to reflect the changes made as outlined.

**SECTION 3.** The City Clerk shall attest to the passage of this resolution and it shall thereupon be in full force and effect.
