

**RESOLUTION NUMBER 4438**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA, FOR MODIFYING THE EMPLOYER PAID MEMBER CONTRIBUTIONS TO THE CALIFORNIA PUBLIC EMPLOYEES' RETIREMENT SYSTEM.**

**WHEREAS**, the City Council of the City of Perris ("City Council") has the authority to implement Government Code Section 20691; and

**WHEREAS**, the City Council has a written labor policy or agreement which specifically provides for the normal members contributions to be paid by the employer; and

**WHEREAS**, one of the steps in the procedures to implement Section 20691 is the adoption by the City Council of a Resolution to commence said Employer Paid Member Contributions (EPMC); and

**WHEREAS**, the City Council has identified the following conditions for the purpose of its election to pay EPMC:

- This benefit shall apply to all employees in Employee Organization represented by Local 911 of California Teamsters and non-represented Confidential classifications of the local miscellaneous group.
- Effective July 17, 2011, for all current Teamster and Confidential employees, the employer shall pay 4% of the normal member contributions as EPMC.
- Effective July 17, 2011, for all future Teamster and Confidential employees (hired after July 17, 2011), the employer shall pay 0% of the normal member contributions as EPMC.
- The effective date of this resolution shall be July 17, 2011.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Perris, California elects to pay EPMC, as set forth above.

The Mayor shall sign this Resolution and the City Clerk shall certify the adoption of this Resolution.
