

RESOLUTION NO. 4175

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA, AMENDING RESOLUTION NOS. 3997 AND 4129 BY REVISING THE APPROPRIATION LIMITS FOR FISCAL YEARS 2007/08 AND 2008/09

WHEREAS, on June 26, 2007, the City Council of the City of Perris (the "Council") adopted Resolution No. 3997 (the "Resolution 3997") establishing the appropriations limit for Fiscal Year 2007/08 pursuant to Article XIII B of the California Constitution; and

WHEREAS, on June 24, 2008, the Council adopted Resolution No. 4129 (the "Resolution 4129") establishing the appropriations limit for Fiscal Year 2008/09 pursuant to Article XIII B of the California Constitution; and

WHEREAS, the City has determined to amend the amounts stated in Resolution 3997 and Resolution 4129 downward by calculating the appropriations limit using 8 decimal places and more accurately reflect the limits; and

WHEREAS, the appropriations in Fiscal Year 2007/08 did not exceed the revised limit described below; and

WHEREAS, the City desires to revise the appropriations limit of \$26,629,132 listed in the Resolution 3997 to be \$26,628,434; and

WHEREAS, the City desires to revise the appropriations limit of \$29,363,944 listed in the Resolution 4129 to be \$29,362,060; and

WHEREAS, there is on file with the City Clerk a statement of the revised calculations; and

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF PERRIS DOES HEREBY RESOLVE AS FOLLOWS:

1. The foregoing recitals are true and correct.
2. The City Council hereby adjusts the appropriations limit of \$26,629,132 approved in the Resolution 3997 to \$26,628,434 and hereby approves \$26,628,434 as the true and accurate appropriations limit for Fiscal Year 2007/08.
3. The City Council hereby adjusts the appropriations limit of \$26,629,132 approved in the Resolution 4129 to \$29,362,060 and hereby approves \$29,362,060 as the true and accurate appropriations limit for Fiscal Year 2008/09.

4. That, except as amended hereby, Resolutions 3997 and 4129 are in full force and effect. The City Council hereby reaffirms all elections made by the City Council pursuant to Resolutions 3997 and 4129

5. The City Clerk shall certify as to the adoption of this Resolution.
