

**RESOLUTION NO. 4219**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS  
ADOPTING THE 2009-2014 COMMUNITY DEVELOPMENT BLOCK  
GRANT (CDBG) PROGRAM CONSOLIDATED PLAN, THE 2009-2010  
CONSOLIDATED ONE-YEAR ANNUAL ACTION PLAN, AND THE  
ANALYSIS OF IMPEDIMENTS TO FAIR HOUSING**

**WHEREAS**, the City of Perris (the "City") has chosen to end its participation under Riverside County's CDBG Program, effective June 30, 2009, and contract directly with the federal Department of Housing and Urban Development (HUD) as an entitlement jurisdiction for CDBG funds; and

**WHEREAS**, the City has prepared all documents, notices, and forms required by HUD for participation in the CDBG Program by entitlement jurisdictions; and

**WHEREAS**, on December 9, 2008, the City Council adopted a Citizen Participation Plan establishing the policies and procedures to be followed in the preparation of the 2009-2014 Consolidated Plan, the 2009-2010 Annual Action Plan, and the Analysis of Impediments to Fair Housing; and

**WHEREAS**, the City implemented the policies and procedures of the Citizen Participation Plan to ensure appropriate and adequate citizen participation; and

**WHEREAS**, the City has prepared a consolidated plan, which is an entitlement city's comprehensive planning document and a required element for funding under the federal CDBG program; and

**WHEREAS**, the City's 2009-2014 Consolidated Plan, contains a housing and community development needs assessment; a survey of available resources; and a five year strategy that specifies achievable housing and community development goals and programs; and

**WHEREAS**, the City has prepared a one year action plan to implement the first year of the five year strategy of the 2009-2014 Consolidated Plan; and

**WHEREAS**, the 2009-2010 Annual Action Plan establishes a one-year program in compliance with HUD funding allocations and requirements; and

**WHEREAS**, the City has prepared an Analysis of Impediments to Fair Housing that outlines the City's strategy to affirmatively promote equal housing opportunity and remove impediments to fair housing choice; and

**WHEREAS**, the City has given notice of the required public hearing for consideration of approval of the 2009-2014 Consolidated Plan, 2009-2010 Annual Action Plan, and the Analysis of Impediments to Fair Housing; and

**WHEREAS**, the City has held a public hearing to hear public testimony of all interested parties regarding the 2009-2014 Consolidated Plan, 2009-2010 Annual Action Plan, and the Analysis of Impediments to Fair Housing; and

**NOW THEREFORE, IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF PERRIS AS FOLLOWS:**

Section 1: Subsequent to hearing and consideration of all testimony, the City Council hereby adopts the 2009-2014 Consolidated Plan, a copy of which is on file with the City Clerk of the City of Perris.

Section 2: Subsequent to hearing and consideration of all testimony, the City Council hereby adopts the 2009-2010 Annual Action Plan, a copy of which is on file with the City Clerk of the City of Perris.

Section 3: Subsequent to hearing and consideration of all testimony, the City Council hereby adopts the Analysis of Impediments to Fair Housing, a copy of which is on file with the City Clerk of the City of Perris.
