

RESOLUTION NUMBER 4261

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS SUPPORTING PASSAGE OF H.R. 2788 IN THE UNITED STATES HOUSE OF REPRESENTATIVES TO DESIGNATE A DISTINGUISHED FLYING CROSS NATIONAL MEMORIAL AT THE MARCH FIELD AIR MUSEUM.

WHEREAS, Congressman Kenneth S. Calvert submitted HR 2788 to the United States House of Representatives on June 10, 2009.

WHEREAS, HR 2788 would officially designate the memorial under construction at March Air Reserve Base as the Distinguished Flying Cross National Memorial.

WHEREAS, the Distinguished Flying Cross Society is a Veteran's organization representing men and women who flew as a part of their service regardless of the military branch they served under.

WHEREAS, the City of Perris is a proud member of the March Joint Powers Authority, and strongly supports the preservation and celebration of aviation history at the March Field Museum.

WHEREAS, supporting this Resolution will further allow the City of Perris to show its continued support for America's Veterans.

WHEREAS, the City Council of the City of Perris City Council has considered the proposed bill, as introduced in the U.S. House of representatives on June 10, 2009 (attached).

WHEREAS, under California Code of Regulations, Title 14, Section 15000, the expression of support for HR 2788 is not subject to CEQA because there is no possibility of this action resulting in a physical change to the environment.

NOW, THEREFORE, BE IT RESOLVED by the City of Perris City Council as follows:

Section 1. Incorporation of Recitals. The Recitals set forth above are true and correct.

Section 2. Environmental Review. The City Council hereby determines that expressing support for HR 2788 is not a "project" under the California Environmental Quality Act (CEQA) and is exempt from further environmental review, specifically finding that:

- A. The City has complied with the California Environmental Quality Act; and
- B. This determination reflects the independent judgment of the City.

Section 3. Approval and Findings. Based on the information contained within the Staff Report and the accompanying attachments and exhibits, the City Council hereby approves this Resolution officially supporting passage of HR 2788, specifically finding that:

- A. The proposed project is consistent with General Plan objectives, policies and programs.
- B. The proposed project will not adversely affect the public health, safety and welfare.
- C. The proposed project will not adversely affect the environment.

Section 4. Effective Date. This Resolution shall be effective on the date of its adoption.

Section 5. Remaining Provisions. The City Council declares that should any provision, section, paragraph, sentence, or word of this Resolution be rendered or declared invalid by any court of competent jurisdiction, or by reason of any preemptive legislation, the remaining provisions, sections, paragraphs, sentences, and words of this Resolution shall remain in full force and effect.

Section 6. Signatures. The Mayor shall sign this Resolution and the City Clerk shall certify to the passage and adoption of this Resolution.
