RESOLUTION NUMBER 4066

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA, APPROVING MITIGATED NEGATIVE DECLARATION 2245 FOR IMPLEMENTATION OF THE LINE Q STORM DRAIN CHANNEL IMPROVEMENTS (CIP D 008)

WHEREAS, the proposed Line Q Storm Drain Channel Improvement Project complies with the Riverside County Flood Control and Water Conservation District (RCFCD) Master Plan, and is necessary to improve public safety and to protect a 500-acre developed watershed from flooding hazards; and,

WHEREAS, an initial study has been prepared for the proposed Line Q Storm Drain Channel Improvements (CIP D 008), and based upon the environmental information staff has determined that the project could not have a significant adverse effect on the environment, therefore a Mitigated Negative Declaration (2245) has been prepared; and

WHEREAS, the proposed project has been duly noticed in a newspaper of general circulation and direct mailed to the State Clearinghouse, responsible agencies and property owners within 300 feet of the site; and,

WHEREAS, on February 12, 2008, the City Council considered all materials in the staff reports, accompanying documents and exhibits; and,

WHEREAS, the City Council considered minor clarifications that were made to the project description and to the extent of potential project wetlands, which based on more detailed jurisdictional delineation studies, was reduced to only 0.04 acres of wetlands (Reach 2) and 0.14 acres of non-wetland waters (Reach 3) of the State, finding that these clarifications do not alter the analyses or findings presented in the Initial Study and Mitigated Negative Declaration (2245); and,

WHEREAS, the City Council considered and approved the Initial Study and Mitigated Negative Declaration (2245) as corrected, finding that these documents adequately addressed the impacts of the proposed project, were prepared in accordance with the California Environmental Quality Act, and reflected the independent judgment of the City; and,

WHEREAS, all legal prerequisites for the adoption of this resolution have occurred.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Perris, as follows:

Section 1. The above recitals are all true and correct.

Section 2. The City Council has reviewed and considered the environmental documentation for the project prior to taking action on the applications. Based on the analysis contained in the Initial Study and the accompanying environmental information, the City Council finds that:

- A. There is no substantial evidence of potentially significant environmental impacts and a Mitigated Negative Declaration (2245) has been prepared.
- B. The City has complied with the California Environmental Quality Act (CEQA).
- C. Determinations of the City Council reflect the independent judgment of the City.

Section 3. Based on the information contained within the staff report and the accompanying attachments and exhibits, the City Council hereby finds that:

- A. The proposed project is consistent with General Plan objectives, policies and programs.
- B. The proposed project will not adversely affect the public health, safety and welfare.
- C. The proposed project will not aversely affect the environment.

Section 4. The City Council hereby adopts Mitigated Negative Declaration (2245) and approves the Line Q Storm Drain Channel Improvements (CIP D 008), based on the information and findings presented in the City Council Submittal dated January 10, 2008.

Section 5. The City Council declares that should any provision, section, paragraph, sentence, or word of this Resolution be rendered or declared invalid by any court of competent jurisdiction, or by reason of any preemptive legislation, the remaining provisions, sections, paragraphs, sentences and words of this Resolution shall remain in full force and effect.

Section 6. The Mayor shall sign this Resolution and the City Clerk shall certify to its passage and adoption.
