RESOLUTION NUMBER 4115

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA, ADOPTING AMENDMENTS TO ITS CONFLICT OF INTEREST CODE

WHEREAS, Government Code Section 87300, *et seq.*, of the Political Reform Act requires state and local government agencies to adopt conflict of interest codes and amend them on a regular basis; and

WHEREAS, the Fair Political Practices Commission ("FPPC") has adopted a regulation, 2 California Code of Regulations Section 18730, which contains the terms of a standard conflict of interest code which the FPPC recommends be adopted by reference; and

WHEREAS, the City has changed the names of certain positions and has deleted or disbanded others, necessitating an update of the list of designated employees required to disclose economic interests;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Perris, California, as follows:

- Section 1. The terms of 2 California Code of Regulations Section 18730, a current copy of which is attached hereto as Attachment "A", and any amendments to it hereinafter duly adopted by the Fair Political Practices Commission, are hereby adopted and incorporated by reference. Regulation 18730, as amended, and Attachments "B" and "C" to this Resolution, in which members and employees are designated and disclosure categories are set forth and explained, shall constitute the Conflict of Interest Code for the City of Perris.
- **Section 2.** Employees designated in Attachment "B" shall file Statements of Economic Interests (Form 700) with the City Clerk. The City Clerk shall retain a copy of all Statements of Economic Interest and make them available for public inspection and reproduction as required by law.
- **Section 3.** All prior lists of designated employees and positions are hereby repealed.
- **Section 4.** The City Clerk shall certify as to the adoption of this Resolution and cause the filing of the Conflict of Interest Code in the manner prescribed by law.
