

**RESOLUTION NUMBER 3865-A**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
PERRIS, CALIFORNIA, COUNTY OF RIVERSIDE, STATE  
OF CALIFORNIA, AUTHORIZING THE DESTRUCTION OF  
CERTAIN CITY RECORDS**

**WHEREAS**, Section 34090 of the California Government Code authorizes the destruction of City records upon approval of the legislative body of the City and the written consent of the City Attorney, provided that said records do not fall within certain specified categories and are not less than two (2) years old; and

**WHEREAS**, Resolution Number 2147 of the City of Perris adopts specific retention periods ranging from two to five years from the date of creation or from the date of audit; and

**WHEREAS**, the City Clerk has requested authority and the City Attorney has approved the destruction of the attached list of documents (Attachment "A");

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Perris, that the records as listed in Attachment "A" may now be destroyed.
