## RESOLUTION NUMBER 3957

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA, OF PRELIMINARY APPROVAL OF ENGINEER'S REPORT FOR ANNEXATION OF TRACT 31226 TO BENEFIT ZONE 55, CITY OF PERRIS LANDSCAPE MAINTENANCE DISTRICT NUMBER 1

**WHEREAS**, on April 24, 2007, the City Council of the City of Perris, County of Riverside, California ("the City Council") adopted its Resolution Number 3956 directing the Engineer of Work to prepare and file with the City Clerk of said City a report in writing as required by the Landscaping and Lighting Act of 1972; and

**WHEREAS**, said City Council has duly considered said report and each and every part thereof, and finds that each and every part of said report is sufficient, and that no portion of the report requires or should be modified in any respect;

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Perris, California, as follows:

- **Section 1.** That the Engineer's estimate prepared by the City Engineer of the itemized costs and expenses of said work and of the incidental expenses in connection therewith, contained in said report, be, and each of them is hereby, preliminarily approved and confirmed.
- **Section 2.** That the diagram showing the District referred to and described in said report, the boundaries of the subdivisions of the land within said District being the same as existed at the time of passage of said Resolution, is hereby preliminarily approved and confirmed.
- **Section 3.** That the proposed assessment upon the subdivisions of land in said District is in proportion to the estimated benefit to be received by said subdivision, respectively, from said work and of the incidental expenses thereof, as contained in said report, is hereby preliminarily approved and confirmed.
- **Section 4.** That said report shall stand as the Engineer's Report for the purposes of all subsequent proceedings, and pursuant to the proposed District.
