

RESOLUTION NUMBER 4051

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA, RECITING THE FACTS OF THE PERRIS SPECIAL MUNICIPAL ELECTION HELD IN SAID CITY ON NOVEMBER 6, 2007, AND DECLARING THE RESULTS THEREOF.

WHEREAS, a special municipal election was held and conducted in the City of Perris, California, on Tuesday, November 6, 2007, to consider whether the term of the mayor shall be changed from two years to four years (Measure E); and

WHEREAS, notice of said election was duly and regularly given, voting precincts were properly established, and election officers were appointed, all as provided by law; and

WHEREAS, in all respects said election was held and conducted and the votes cast thereat, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in cities; and

WHEREAS, pursuant to Resolution Number 4006 adopted on July 10, 2007, the Riverside County Registrar of Voters canvassed the returns of said election and has certified the results to this City Council, and said results are received, attached and made a part hereof as Exhibit "A";

NOW, THEREFORE, the City Council of the City of Perris does hereby **RESOLVE, DECLARE, DETERMINE** and **ORDER** as follows:

Section 1. That there were twenty-one (21) precincts established for the purpose of holding said election consisting of consolidations of the regular election precincts in the City as established for the holding of state and county elections.

Section 2. That said special municipal election was consolidated with other elections being held in the same territory, with the same voters and held on the same date pursuant to Section 10400 of the Elections Code.

Section 3. That said special municipal election was held solely for the purpose of considering a ballot measure concerning the term of the directly elected Mayor.

Section 4. That the whole number of votes cast at the polls in connection with the City Election was 604, and the whole number of absent voter ballots cast in said City was 869, resulting in a total of 1,473 total votes cast in connection with the City election.

Section 5. That the number of votes given at each precinct and the number of

votes cast are, as listed in Exhibit "A", attached..

Section 6. That the City Council does declare and determine that: Measure E was approved by the voters of the City of Perris by a vote of 975 in support and 477 against.

Section 7. That the City Clerk shall enter on the records of the City Council of said City, a statement of result of said election showing the whole number of votes cast in the City and the number of votes given at each precinct for and against the measure.

Section 8. That the City Clerk shall certify to the passage and adoption of this Resolution; shall enter the same in the book of original Resolutions of said City; and shall make a minute of passage and adoption thereof in the records of the proceeding of the City Council of said City, in the minutes of the meeting at which the same is passed and adopted.
