

RESOLUTION NUMBER 3550

**RESOLUTION OF THE CITY COUNCIL FOR THE CITY OF
PERRIS APPROVING THE NEGATIVE DECLARATION FOR
THE PROPOSED THIRD AMENDMENT TO THE
REDEVELOPMENT PLAN FOR THE 1987
REDEVELOPMENT PROJECT AREA**

WHEREAS, the City Council of the City of Perris (“City Council”) and the Perris Redevelopment Agency (“Agency”) approved and adopted a Redevelopment Plan (“Plan”) for the 1987 Redevelopment Project Area on June 29, 1987, by Ordinance No. 687; and

WHEREAS, the City Council subsequently approved and adopted amendments to the Redevelopment Plan on December 12, 1994, by Ordinance No. 996 (“First Amendment”) and on September 27, 2005, by Ordinance No. 1171 (“Second Amendment”); and

WHEREAS, the Agency has formulated the Third Amendment to the Plan (“Third Amendment”) which would re-authorize the Agency with eminent domain authority within the East San Jacinto Sub Area; and

WHEREAS, a Negative Declaration was prepared on the proposed Third Amendment (“Negative Declaration”) in the form attached herewith as Exhibit “A”; and

WHEREAS, a notice of the availability of the Negative Declaration for public review and comment was published on December 8, 2005, in the *Perris City News*, a newspaper of general circulation in the City of Perris; and

WHEREAS, on January 31, 2006, the Agency and City Council held a joint public hearing on the proposed Third Amendment and received and considered all evidence and testimony pertaining thereto;

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Perris hereby finds and determines that there is not substantial evidence that the proposed Third Amendment will have a significant effect on the environment and that the Negative Declaration reflects the independent judgment and analysis of the City Council based upon the whole record of the Negative Declaration, including the Initial Study contained therein, any comments received and evidence and testimony received at the joint public hearing on the Negative Declaration.

The City Council has reviewed and considered the information contained in the Negative Declaration prepared for the Third Amendment and hereby approves the Negative Declaration.

The City Clerk is authorized to file, in cooperation with the Agency Secretary, a joint Notice of Determination with the County Clerk of the County of Riverside following adoption by the City Council of the ordinance adopting the Third Amendment.
