## RESOLUTION NUMBER 3397

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS. COUNTY **OF** RIVERSIDE, STATE OFCALIFORNIA, APPROVING A NEGATIVE DECLARATION (2177); AND TENTATIVE PARCEL MAP 31677 (03-0332) TO **SUBDIVIDE FOUR** *(4)* LOTS INTO **SEVEN** COMMERCIAL LOTS TOTALING 6.02 NET ACRES, NORTH RAMONA **EXPRESSWAY** BETWEEN **BRENNAN** AVENUE AND WEBSTER AVENUE; AND MAKING FINDINGS IN SUPPORT THEREOF

**WHEREAS**, on September 24, 2003, the applicant applied for a Tentative Parcel Map 31677 (03-0332) to subdivide four (4) lots into seven (7) commercial lots, north of Ramona Expressway between Brennan Avenue and Webster Avenue; and,

**WHEREAS**, the City Council of the City of Perris adopted a General Plan to guide development throughout the City and a Zoning Ordinance to implement the vision set forth in the General Plan; and,

WHEREAS, on February 16, 2005, the Planning Commission conducted duly noticed public hearing on the proposed project, considered testimony and materials in the staff report and accompanying documents, and recommended approval of the proposed project, subject to and addition of item 16 to the Engineering Conditions of Approval to read, "The configuration of the intersections of Ramona Expressway with Webster Avenue and Ramona Expressway with Brennan Avenue including transitions, and any and all driveways, shall be approved by the City Engineer"; and,

**WHEREAS**, on April 26, 2005, the City Council conducted a duly noticed public hearing on the proposed project, considered testimony and materials in the staff reports, accompanying documents and exhibits; and,

**WHEREAS**, the City Council considered and approved the Initial Study and Negative Declaration (2177) for the project, finding that these documents adequately addressed the impacts of the proposed project, were prepared in accordance with the California Environmental Quality Act, and reflected the independent judgment of the City; and,

**WHEREAS**, all legal prerequisites for the adoption of this resolution have occurred;

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Perris, California, as follows:

**Section 1.** The above recitals are all true and correct.

- **Section 2.** The City Council has reviewed and considered the environmental documentation for the project prior to taking action on the applications. Based on the analysis contained in the Initial Study and the accompanying environmental information, the City Council finds that:
  - A. There is no substantial evidence of potentially significant environmental impacts and a Negative Declaration (2177) has been prepared.
  - B. The City has complied with the California Environmental Quality Act (CEQA).
  - C. Determinations of the Planning Commission reflect the independent judgment of the City.
- **Section 3.** Based on the information contained within the Project Report and the accompanying attachments and exhibits, the City Council hereby finds that:
  - A. The proposed project is consistent with General Plan objectives, policies and programs.
  - B. The proposed project will not adversely affect the public health, safety and welfare.
  - C. The proposed project will not adversely affect the environment.
- **Section 4.** The City Council hereby adopts Negative Declaration (2177), and Tentative Parcel Map 31677 (03-0332) based on the information and findings presented in the staff report dated April 26, 2005.
- **Section 5.** The City Council declares that should any provision, section, paragraph, sentence, or word of this Resolution be rendered or declared invalid by any court of competent jurisdiction, or by reason of any preemptive legislation, the remaining provisions, sections, paragraphs, sentences and words of this Resolution shall remain in full force and effect.
- **Section 6.** The Mayor shall sign this resolution and the City Clerk shall certify to the passage and adoption of this Resolution.
