

**RESOLUTION NUMBER 3421**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA, APPROVING COMMUNITY DEVELOPMENT BLOCK GRANT AND HOME THREE-YEAR COOPERATION AGREEMENT WITH RIVERSIDE COUNTY AND AUTHORIZING THE MAYOR TO EXECUTE THE AGREEMENT**

**WHEREAS**, the County of Riverside has qualified as an urban county for the purposes of receiving a Community Development Block Grant from the United States Department of Housing and Urban Development, (HUD), under Title 1 of the Housing and Community Development Act of 1974, as amended, and

**WHEREAS**, the City of Perris has elected to participate with the County of Riverside (EDA) to assist and undertake essential community development and housing assistance activities pursuant to past cooperation agreements for Community Development Block Grant Funds and the Housing and Community Development Act of 1974; and

**WHEREAS**, the City of Perris has elected to continue to participate as a cooperating city with the Urban County of Riverside County for Federal Fiscal Years 2006-2007, 2007-2008, 2008-2009, and

**WHEREAS**, the standard three-year cooperation agreement has been revised to incorporate recent changes in federal legislation and regulations; and

**WHEREAS**, the three-year cooperation agreement will allow the City of Perris to carry out activities which are funded by Community Development Block Grants and HOME funds; and

**WHEREAS**, the three year cooperation agreement will allow the City of Perris to participate in the Urban County Consolidated Planning Programs;

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Perris, California, as follows:

**Section 1.** Approval and Authorization For Execution of Agreement:

- A. The standard three-year cooperation agreement with Riverside County is hereby approved.
- B. Upon approval of the three-year cooperation agreement by the City Council, the Mayor is hereby authorized to execute the agreement

on behalf of the City, and the said agreement shall be effective on the date the Mayor executes the agreement.

**Section 11.** Certification. The City Clerk shall certify to the adoption of this Resolution.
