A RESOLUTION OF THE PERRIS CITY COUNCIL IN SUPPORT OF THE URGENCY ORDINANCE OF THE COUNTY OF RIVERSIDE REGARDING THE RELEASE OF REGISTERED SEXUAL OFFENDERS

WHEREAS, on May 24, 2005, in response to public concerns over the release of a registered high-risk sex offender to a group home in Mead Valley near a school, the Riverside County Board of Supervisors adopted County Ordinance No. 842, "An Urgency Ordinance of the County of Riverside Regarding the Release of Registered High-Risk Sexual Offenders"; and

WHEREAS, County Ordinance No. 842 provides for the supervision and monitoring of persons convicted of a felony sexual offense, who are subject to the registration requirements of California Penal Code Section 290, and who are released within the unincorporated area of Riverside County; and

WHEREAS, pursuant to County Ordinance No. 842, local law enforcement authorities would be notified and be able to alert residents as to the identity and address of any registrant coming into the community, and to ensure that the registrant not be within one and one-half miles of any school, park, or place where minors congregate; and

WHEREAS, the City Council desires to express publicly their support for the County's efforts to impose additional controls on the release and supervision of registered sex offenders in Riverside County.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF PERRIS, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

- **Section 1.** The foregoing recitals are incorporated herein as if set forth in full.
- **Section 2.** The City Council hereby declares its support for County Ordinance No. 842.
- **Section 3.** The Mayor shall sign this Resolution and the City Clerk shall certify to the adoption of this Resolution.
