WHEREAS, on September 29, 1997, the City Council adopted Resolution Number 2631 revising the Facilities Use Policies and Fee Schedule of the Recreation Department and establishing a new fee schedule to cover the cost of providing services to all who use the recreation facilities; and

WHEREAS, on January 28, 2003, the City Council adopted Resolution Number 3067 revising the Indoor Facilities Use Fees for User Groups from a daily fee to an hourly fee; and

WHEREAS, the revised Fee Schedule for Community Services facilities has been amended as follows in Attachment "A" to this Resolution.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Perris, California, as follows:

Section 1. Resolution Number 3067 is hereby rescinded.

Section 2. The City Council adopts the revised Facilities Use Policies and Fee Schedule as set forth in Attachment "A", attached hereto and incorporated herein by this reference.
